THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections 13, 14, 15, 16, 28 and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

1. The Post Office (Inland Post) Order, 1983, as amended (b) is further amended as follows:-

(a) Paragraph 5 of the First Schedule thereto is repealed and the schedule set out in the First Schedule to this Order is substituted therefor.

(b) Part I of the Sixth Schedule thereto is repealed and the schedule set out in the Second Schedule to this Order is substituted therefor.


Citation.
