GUERNSEY STATUTORY INSTRUMENT

The Social Insurance (Contributions)(Amendment)(No.2)  
(Guernsey) Regulations, 1982.

Made ..... 13 December, 1982  
Laid before the States .....

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section six of the Social Insurance (Guernsey) Law, 1978<sup>(a)</sup>, as amended, and of all other powers enabling it in that behalf, hereby orders:-

Amendment to regulation eleven of the principal regulations

1. Regulation 11 of the Social Insurance (Contributions)(Guernsey) Regulations, 1978<sup>(b)</sup>, as amended<sup>(c)</sup>, is hereby further amended as follows:-

(a) paragraphs (2) and (3) thereof are hereby repealed, and the following paragraph is hereby substituted therefor:-

"(2) A person to whom a certificate of assessment has been granted shall be liable to pay Class 2 contributions in such amount as shall be specified in the certificate in respect of each week of the period which shall be specified by the Authority in the certificate, being -

- (a) in the case where the application for the certificate was made before the expiration of the contribution year to which the application relates, the whole of that contribution year;
- (b) in the case where the application was made after the expiration of the contribution year to which the application relates, the period commencing on the first day of that contribution year if, in the opinion of the Authority, there was good cause for the application to have been made after the end of that contribution year."

Repeal

2. Paragraph (2) of regulation 3 of the Social Insurance (Contributions) (Amendment)(Guernsey) Regulations, 1982, is hereby repealed.

Citation and collective title


3. (1) These regulations may be cited as the Social Insurance (Contributions)(Amendment)(No.2)(Guernsey) Regulations, 1982.

(2) These regulations, the Social Insurance (Contributions) (Amendment)(Guernsey) Regulations, 1982, and the Social Insurance (Contributions)(Guernsey) Regulations, 1978 to 1981, may be cited together as the Social Insurance (Contributions)(Guernsey) Regulations, 1978 to 1982.

Commencement

4. These regulations shall come into force on the first day of January nineteen hundred and eighty- three.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport)

Regulation one of these regulations amends regulation eleven of the principal regulations so as to enable an application for a Certificate of Assessment to be made retrospective to an earlier year if, in the opinion of the Authority there was good cause for the application to have been made after the end of the relevant contribution year. Regulation two is of a consequential nature.
