

GUERNSEY STATUTORY INSTRUMENT

The Social Insurance (Contributions)(Amendment)
(No.2) (Guernsey) Regulations, 1983

Made 23rd September, 1983
Laid before the States
Coming into operation 1st January, 1984.

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section twenty of the Social Insurance (Guernsey) Law, 1978 (a), as amended (b), and in exercise of all other powers enabling it in that behalf, hereby orders:-

Amendment of the Seventh Schedule to the principal regulations

1. The Seventh Schedule to the Social Insurance (Contributions) (Guernsey) Regulations, 1978 (c), as amended (d), is hereby repealed and the Schedule set out in the Schedule to these regulations is hereby substituted therefor.

Repeal

2. (1) The Social Insurance (Contributions)(Amendment)(Guernsey) Regulations, 1982, are hereby repealed.

(2) Paragraph (2) of regulation two of the Social Insurance (Contributions)(Amendment)(Guernsey) Regulations, 1983, is hereby repealed.

Citation and collective title

3. (1) These regulations may be cited as the Social Insurance (Contributions)(Amendment)(No.2)(Guernsey) Regulations, 1983.

(2) These regulations, the Social Insurance (Contributions) (Guernsey) Regulations, 1978 to 1982, and the Social Insurance (Contributions)(Amendment)(Guernsey) Regulations, 1983, may be cited together as the Social Insurance (Contributions)(Guernsey) Regulations, 1978 to 1983.
