The Social Insurance (Contributions) (Amendment)
Regulations, 1990

Made 2nd November, 1990.
Laid before the States 12th December, 1990
Coming into force 1st January, 1991.

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section 20 and section 116 of the Social Insurance (Guernsey) Law, 1978, as amended(*a*), hereby orders:—

Amendment

1. The Seventh Schedule to the Social Insurance (Contributions) (Guernsey) Regulations, 1978, as amended(*b*), is substituted by the Schedule set out in the Schedule to these Regulations.

Repeal

2. The Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1989(*c*), are repealed.

Extent

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation

4. These Regulations may be cited as the Social Insurance (Contributions) (Amendment) Regulations, 1990.

Collective Title

5. These Regulations and the Social Insurance (Contributions) (Guernsey) Regulations, 1978 to 1988, may be cited together as the Social Insurance (Contributions) Regulations, 1978 to 1990.

Commencement

6. These Regulations shall come into force on the 1st day of January, 1991.
