**The Driving Tests (Increase of Fees) Regulations, 2007**Made ----- 31<sup>st</sup> October, 2007

Laid before the States on ----- December, 2007

Coming into operation on----- 1<sup>st</sup> January, 2008

**THE ENVIRONMENT DEPARTMENT**, in exercise of the powers conferred upon it by sections 2A(b) and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987, as amended <sup>(1)</sup>, hereby orders:-

**Amendment to 1995 Ordinance**

1. For Schedule 2 to the Driving Licences (Guernsey) Ordinance, 1995, as amended <sup>(2)</sup>, substitute the following Schedule-

“ SCHEDULE 2 Section 4

*Driving test fees*

The fee payable prior to taking a test of competence relating to a motor vehicle of a class included in the category set out in column (1) of the Table below shall be the corresponding sum set out in column (2) thereof.

## **The Driving Tests (Increase of Fees) Regulations, 2007**

### **Explanatory Note**

These regulations set the fees that are chargeable for tests of competence to drive with effect from 1<sup>st</sup> January 2008, by increasing approximately by RPI the current fees that are set out in Schedule 2 to the Driving Licences (Guernsey) Ordinance, 1995, as amended.
