THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections 13, 14, 15, 16, 18, 20, 23, 28 and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

1. The Post Office (Inland Post) Order, 1983, as amended (b), is hereby further amended as follows:-

- (a) in Section 16 (2) thereof for the words "fifty-five new pence" there is substituted "£1.00";
- (b) in Section 30 (2) thereof for the words "ten pounds" there is substituted "£20";
- (c) in Section 38 thereof for the words "eighteen pounds" there is substituted "£20";
- (d) in Section 44 thereof -
 - (i) in subsection (1), for "£18" there is substituted "£20";
 - (ii) in subsection (2) the words "caused either by physical means or through deterioration" are repealed;
- (e) in the Third Schedule in paragraph 4 (b) thereto after the word "Jersey" there is inserted the words "Republic of Ireland";

- (g) Part I of the Fifth Schedule thereto is repealed and the Part set out in the First Schedule to this Order is substituted therefor;
- (h) Part I of the Sixth Schedule thereto is repealed and the Part set out in the Second Schedule to this Order is substituted therefor;
- (i) the First, Second, Seventh and Eighth Schedules thereto are repealed and the Schedules set out in the Third and Fourth Schedules to this Order are respectively substituted therefor.


