The Health Service (Pharmaceutical)(Prescribed Appliances)
(Amendment)(No.2)(Guernsey) Regulations, 1980

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by the Health Service (Pharmaceutical)(Guernsey) Law, 1972, as modified by the Health Service (Pharmaceutical)(Prescribed Appliances) (Guernsey) Ordinance, 1977, and of all other powers enabling it in that behalf, hereby orders:-

Amendment of regulation eight of the principal regulations

1. Paragraph (2) of regulation eight of the Health Service (Pharmaceutical)(Prescribed Appliances)(Guernsey) Regulations, 1977, (a) as amended (b) (hereinafter referred to as "the principal regulations"), is hereby further amended as follows:-

- (a) in sub-paragraph (b) thereof, the words "twenty-one per centum" are hereby repealed and the figures and words "22.75 per centum" are hereby substituted therefor.

Supplemental payment to suppliers of prescribed appliances

2. An approved appliance supplier shall be paid out of the Guernsey Health Service Fund in respect of each prescribed appliance within the meaning of the principal regulations -

- (a) which was supplied by him under the Law during the period commencing on the first day of August, nineteen hundred and seventy-nine and ending on the thirty-first day of July, nineteen hundred and eighty, and
- (b) in respect of which payment was made out of that Fund upon the receipt by the Authority of a certificate relating to any part of that period and issued by the body appointed by the Authority to calculate the sum payable to approved suppliers in respect of pharmaceutical benefit supplied by them under the Law;

in addition to that payment a sum equal to 2.556 per centum of the amount paid in respect of that appliance under regulation 8 of the principal regulations as amended.

Repeal

3. Paragraph (2) of regulation 3 of the Health Service (Pharmaceutical)(Prescribed Appliances)(Amendment)(Guernsey) Regulations, 1980 (c) is hereby repealed.

Citation, collective title and commencement

4. (1) These regulations may be cited as the Health Service (Pharmaceutical)(Prescribed Appliances)(Amendment)(No.2)(Guernsey) Regulations, 1980.

(2) These regulations together with the Health Service (Pharmaceutical)(Prescribed Appliances)(Amendment)(Guernsey) Regulations, 1980 (c) and the Health Service (Pharmaceutical)(Prescribed Appliances)(Guernsey) Regulations, 1977 to 1979 (d) may be cited together as the Health Service (Pharmaceutical)(Prescribed Appliances)(Guernsey) Regulations, 1977 to 1980.

(3) These regulations shall be deemed to have come into operation on the first day of September, nineteen hundred and eighty.
