The Parking Places (Amendment) (No. 2) Order, 2002Made ----- 6th September, 2002Coming into operation on ----- 9th September, 2002

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1991, as amended(b) is further amended in accordance with Articles 2 to 7 inclusive of this Order.
2. In Part C of Schedule 1, immediately following the entry relating to Disc Parking Place No. DC32 insert the following entries-

“DC33	Victoria Road	The south-west and west sides of the portion of the road between the junctions with Valnord and Grange Road.
DC34	Victoria Road	The east side of the portion of the road between the junctions with La Couperderie and Grange Road, but excluding Approved Parking Place No. AB14.
DC35	George Road	The east side of the road within the limits indicated by signs.
DC36	L'Hyvreuse	The south side of the road within the limits indicated by signs.
DC37	Les Canichers	The north-west side of the road but excluding Approved Parking Place No. AB16.
DC38	Les Canichers	The portion of the south-east side of the road within the limits indicated by signs.

3. In Part D of Schedule 1, the entries relating to Disc Parking Places Nos. DD13, DD15, DD21 and DD22 are deleted.

4. In Part E of Schedule 1, for the entry relating to Disc Parking Place No. DE8 substitute the following entry -

"DE8	George Road	The east side of the road within the limits indicated by signs."

5. In Part E of Schedule 1, the entries relating to Disc Parking Places Nos. DE23 and DE24a are deleted.

6. In Part B of Schedule 2, for the entry relating to Approved Parking Place No. AB11 substitute the following entry -


"AB11	Victoria Road	On the south side of the road within the limits indicated by signs."

7. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC17 insert the following entries -

"AC18	Lower Pollet	The east side of the road immediately to the south of its junction with Le Truchot.
AC19	Union Street	The north side of the road immediately to the east of the un/loading bay."

8. This Order may be cited as the Parking Places (Amendment) (No. 2) Order, 2002.
9. This Order shall come into force on the 9th of September, 2002.
