The Parking Places (Amendment) Order, 1981

Made the 16th day of November, 1981

Coming into force on the 23rd day of November, 1981

THE ISLAND POLICE COMMITTEE, in exercise of the powers conferred upon it by section one of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1968, as amended(b), is hereby further amended as follows:-

- (a) in section two thereof the words "Part II and Part III" are repealed and the words "Part II, Part III and Part IV" are substituted therefor;
- (b) in paragraph (a) of section nine thereof the letters and figures "No. D21" are repealed and the word, letters and figures "Nos. D21 and D115" are substituted therefor;
- (c) in paragraph (b) of section nine thereof the letter and figures "D97" are repealed;
- (d) in paragraph (c) of section nine thereof immediately after the letter and figures "D73" there are inserted the letter and figures "D74";
- (e) in paragraph (d) of section nine thereof the word, letters and figures "D104 and D109" are repealed and the word, letters and figures "D104, D109 and D116" are substituted therefor;
- (f) in paragraph (g) of section nine thereof the word, letters and figures "D113 and D114" are repealed and the word, letters and figures "D113, D114, D117 and D118" are substituted therefor;
- (g) immediately after section ten thereof there is inserted the following additional section numbered "10A" -

"10A. A person, being in charge of a vehicle or a motor bicycle other than a vehicle or motor bicycle being used for police


purposes, shall not, without the permission of the Chief Officer, park that vehicle or motor bicycle, as the case may be, in any of the approved parking places set out in Part IV of the First Schedule to this Order.";

- (h) the entry relating to disc parking place No. D2 in the third column of Part I of the First Schedule thereto is repealed and the entry "The north side of the road between a parking sign placed at the eastern extremity of approved parking place No.PV1 and a parking sign placed as near as may be to the eastern end of the road." is substituted therefor;
- (i) the entry relating to disc parking place No. D66 in the third column of Part I of the First Schedule thereto is repealed and the entry "The west side of the road between a parking sign placed as near as may be to the old water pump and a parking sign placed as near as may be to a house called "Ty-Gwyn", Doyle Road." is substituted therefor;
- (j) immediately after the entries relating to disc parking place No.D73 in each of the columns of Part I of the First Schedule thereto there are inserted respectively the entries in each of the columns of the First Schedule to this Order;
- (k) the entries relating to disc parking place No.D97 in each of the columns of Part I of the First Schedule thereto are repealed;
- (l) immediately after the entries relating to disc parking place No.D114 in each of the columns of Part I of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Second Schedule to this Order;
- (m) immediately after the entries relating to approved parking place No.A58 in each of the columns of Part II of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Third Schedule to this Order;
- (n) immediately after the entries relating to approved parking place No.MB18 in each of the columns of Part III of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Fourth Schedule to this Order;
- (o) immediately after Part III of the First Schedule thereto there is inserted the additional Schedule entitled "PART IV - APPROVED PARKING PLACES - Police Vehicles and Police Motor Bicycles" set out in the Fifth Schedule to this Order.

2. This Order may be cited as the Parking—Places (Amendment) Order, 1981.

3. This Order shall come into force on the twenty-third day of November, nineteen hundred and eighty-one.

FIRST SCHEDULE

Section one (j)

"D74 Bridge Road, Saint Sampson. The south side of the road between its junction with New Road and its junction with Nocq Road where indicated by a parking sign. "

SECOND SCHEDULE

Section one (l)

"D115 Vauvert, Saint Peter Port. The west side of the road between a parking sign placed as near as may be to its junction with George Street and a parking sign placed as near as may be to the pedestrian crossing at its junction with Victoria Road.

D116 Le Truchot, Saint Peter Port. The more westerly of two off-street public parking areas at Le Truchot adjacent to its junction with Sir William Place within the limits indicated by parking signs.

D117 Le Truchot, Saint Peter Port. The more easterly of two off-street public parking areas at Le Truchot adjacent to its junction with Sir William Place within the limits indicated by parking signs.

D118 Monument Gardens, Saint Peter Port. The whole of the area of the former Odeon Cinema Car Park, but excluding that portion of the eastern end indicated by parking signs as being reserved for the parking of motor bicycles. "

THIRD SCHEDULE

Section one (m)

"A59 L'Hyvreuse, Saint Peter Port. The south side of the road between a parking sign placed as near as may be to the Duke of Richmond Hotel and a parking sign placed as near as may be opposite the turning point at the eastern end of Churchill Avenue, Cambridge Park. "

FOURTH SCHEDULE

Section one (n)

"MB19 Monument Gardens, Saint Peter Port. The portion of the eastern end of the area of the former Odeon Cinema Car Park indicated by parking signs as being reserved for motor bicycles. "

Section one (o)

PART IV - APPROVED PARKING PLACES

Police Vehicles and
Police Motor Bicycles

PV 1 Saint James Street,
Saint Peter Port.

The north side of the road between a parking sign placed as near as may be opposite its junction with New Street and a parking sign placed at the western extremity of disc parking place No.D2 indicated as being reserved for Police vehicles."
