The Social Insurance (Contributions) (Amendment)
(Guernsey) Regulations, 1986

Made 6th January, 1986

Laid before the States , 1986

Coming into operation ... 6th January, 1986

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section eleven of the Social Insurance (Guernsey) Law, 1978, as amended (a), and in exercise of all other powers enabling it in that behalf, hereby orders:-

Amendments to Regulations of 1978

1. Immediately after Regulation 37 of the Social Insurance (Contributions) (Guernsey) Regulations, 1978 (b) there is hereby inserted the following additional Regulation numbered "37A" -

"Credits for persons in receipt of Invalid Care Allowance

37A. (1) Subject to the provisions of these Regulations and of the Social Insurance (Married Women and Widows) (Guernsey) Regulations, 1978 (hereafter in this Regulation referred to as "the Married Women and Widows Regulations of 1978") an insured person who would otherwise be liable to pay a Class 3 contribution shall be entitled to be credited with a Class I contribution in respect of any week in which an Invalid Care Allowance is payable in accordance with the provisions of the Attendance and Invalid Care Allowances (Guernsey) Law, 1983 (hereafter in this Regulation referred to as "the Law of 1983").

(2) Notwithstanding the provisions of the last preceding paragraph a married woman who, in the week immediately preceding the week in which an Invalid Care Allowance is payable, was employed in employed contributor's employment and, in accordance with Regulation 2 of the Married Women and Widows Regulations of 1978 had not elected not to be liable to pay a primary Class I contribution under section 5 of the Law shall be deemed to have made an election under and in accordance with Regulation 4 of the Married Women and Widows Regulations of 1978, and shall be entitled to be credited with a Class I contribution in respect of any week in which an Invalid Care Allowance is payable in accordance with the Law of 1983."

Extent

2. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation

3. These Regulations may be sited as the Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1986.

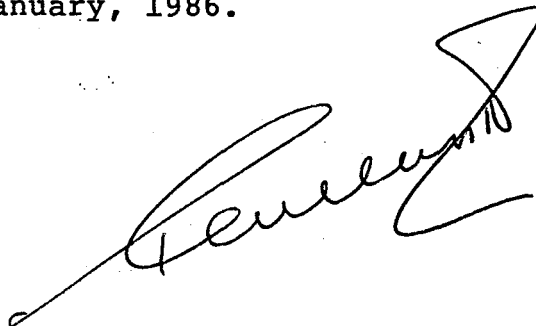
Collective Title

4. These Regulations and the Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1978 to 1985, may be cited together as the Social Insurance (Contributions) (Guernsey) Regulations, 1978 to 1986.

Commencement

5. These Regulations shall come into force on the 6th day of January, 1986.
