The Post Office (Overseas Letter Post) (Amendment) (No. 2) Order, 1986

THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections 13, 16 and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

1. The Post Office (Overseas Letter Post) Order, 1983, as amended (b), is hereby further amended as follows:-

- (a) in Section 25 (2) (c) thereof for "£1.10" there is substituted "£1.20";
- (b) in Section 32 (1) and (3) thereof for the words "twenty new pence" and "forty new pence" there is substituted "21p" and "42p" respectively;
- (c) in the Second Schedule, Part 2 (5) thereof for "13p" there is substituted "12p";
- (d) the Third and Sixth Schedules thereto are repealed and the Schedules set out in the First and Second Schedules to this Order are respectively substituted therefor.


