THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections 13, 16 and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

Amendments to Overseas Letter Post Order of 1983.

1. The Post Office (Overseas Letter Post) Order, 1983, (b), is hereby amended as follows:-

The First, Second, Third and Fourth Schedules thereto are repealed and the Schedules set out in the First, Second, Third and Fourth Schedules to this Order are respectively substituted therefor.

2. This Order may be cited as the Post Office (Overseas Letter Post) (Amendment) (No. 2) Order, 1990.
