**The Social Insurance (Classification) (Amendment)
Regulations, 1995**

Made 29th September, 1995

Laid before the States

Coming into operation 1st January, 1996

THE GUERNSEY SOCIAL SECURITY AUTHORITY, in exercise of the powers conferred upon it by section 1 and section 116 of the Social Insurance (Guernsey) Law, 1978, as amended(a), hereby orders:-

Amendments

1. In the the First Schedule to the Social Insurance (Classification) (Guernsey) Regulations, 1978, as amended(b):-

(a) after paragraph 7A of Part II there is inserted the following paragraph:

"

7B Employment by a limited liability company where the Authority is satisfied that the employee, his spouse, nominee or other agent is beneficially entitled to such proportion of the shares of that company as to have substantial control of its operations.	None.

(b) in paragraph 8 of Part III thereof:

(i) in sub-paragraph (a), "£30.00" is deleted and the following substituted therefor:

"one quarter of one fifty-second of the lower annual income limit prescribed under section 8(4) of the Law"

(ii) in sub-paragraph (b) "£130.00" is deleted and the following substituted therefor:

"one quarter of one twelfth of that limit."

Repeals

2. Regulation 2 of the Classification (Amendment) Regulations, 1994(c) is repealed.

Extent

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation

4. These Regulations may be cited as the Social Insurance (Classification) (Amendment) Regulations, 1995.

Commencement

5. These Regulations shall come into force on the 1st day of January, 1996.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations further amend the Social Insurance (Classification) (Guernsey) Regulations, 1978 so as to provide

- (a) that an insured person who is employed under a contract of service by a company which he controls is to be treated as self-employed
- (b) that the earnings threshold, below which people are considered to be non-employed, should be related to the lower annual income limit prescribed for income-related non-employed contributions.
