The Social Insurance (Contributions) (Amendment)
(Guernsey) Regulations, 1987

Made 27th October, 1987
Laid before the States
Coming into operation 1st January, 1988

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section 20 and section 104(3) of the Social Insurance (Guernsey) Law, 1978, as amended^(a), hereby orders:-

Amendment of Regulation 79 of the principal Regulations

1. In Regulation 79 of the Social Insurance (Contributions) (Guernsey) Regulations, 1978, as amended^(b), (hereinafter referred to as "the principal Regulations") the words "one hundred pounds" are hereby repealed and the words "four hundred pounds" are hereby substituted therefor and the words "ten pounds" are hereby repealed and the words "twenty pounds" are hereby substituted therefor.

Amendment of the Seventh Schedule to the principal Regulations

2. The Seventh Schedule to the principal Regulations is hereby repealed and the Schedule set out in the Schedule to these Regulations is hereby substituted therefor.

Repeal

3. The Social Insurance (Contributions) (Amendment) (No.2) (Guernsey) Regulations, 1986^(c), are hereby repealed.

Extent

4. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

5. These Regulations may be cited as the Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1987.

Collective title

6. These Regulations, the Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1986 and the Social Insurance (Contributions) (Guernsey) Regulations, 1978 to 1985 may be cited together as the Social Insurance (Contributions) (Guernsey) Regulations, 1978 to 1987.

Commencement

7. These Regulations shall come into force on the 1st day of January, 1988.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport)

These Regulations amend the penalties which may be imposed for failing to comply with the Regulations so as to bring them into correspondence with the provisions of the Social Insurance (Guernsey) Law, 1978 and specify the lower weekly earnings limit and the lower monthly earnings limit as respects the contribution year commencing on 1 January, 1988.
