**The Social Insurance (Contributions) (Amendment) (No.2)  
Regulations, 1993**

**THE GUERNSEY SOCIAL SECURITY AUTHORITY**, in exercise of the powers conferred upon it by sections 20 and 116 of the Social Insurance (Guernsey) Law, 1978, as amended(a), hereby orders:-

**Amendment**

1. In the Social Insurance (Contributions) Regulations, 1978(b) (the "principal Regulations"):

(a) in Regulation 38

- (i) in paragraph (2) the words "in relation to any person who has not attained the age of eighteen" and "or the week in which he attains the age of eighteen, whichever first occurs" are deleted;
- (ii) in paragraph (3) b) the words "and is not entitled to be credited with a reckonable contribution under regulation thirty-six of these regulations" are deleted;

(b) in regulation 58

- (i) at paragraph (7) (a) for "eighteen" substitute "twenty" and after the words "contributor's employment" insert "prior to the 1st of January of the year in which age twenty is attained";
- (ii) at paragraph (7) (b) the words "who is over the age of eighteen" are deleted;
- (iii) paragraph (9) is deleted.

**Repeals**

2. Regulations 33, 35 and 36 of the principal Regulations are repealed

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.


**Citation**

**EXPLANATORY NOTE**

(This note is not part of the regulations, but explains their general purport)

These Regulations are consequential on the amendment to the Social Insurance Law which reduced the average period for the calculation of entitlement to old age pension, death grant and widow's benefits.
