THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by sections 23 and 29 of the Health Service (Pharmaceutical)(Guernsey) Law, 1972, as amended, and as modified by section 1 of the Health Service (Pharmaceutical) (Prescribed Appliances)(Guernsey) Ordinance, 1977<sup>(a)</sup>, hereby orders :-

Amendment

1. The First Schedule to the Health Service (Pharmaceutical) (Prescribed Appliances) (Guernsey) Regulations, 1977, as amended<sup>(b)</sup>, is hereby repealed and the Schedule set out in the Schedule to these Regulations is substituted therefor.

Repeal

2. The Health Service (Pharmaceutical) (Prescribed Appliances) (Amendment) (Guernsey) Regulations, 1989<sup>(c)</sup>, are hereby repealed and Regulation 5 of the Health Service (Pharmaceutical) (Prescribed Appliances) (Amendment) (Guernsey) Regulations, 1990<sup>(d)</sup> is repealed.

Extent

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation

4. These Regulations may be cited as the Health Service (Pharmaceutical)(Prescribed Appliances)(Amendment No.2) Regulations, 1990.
