THE HORTICULTURAL INDUSTRY (STATISTICAL INFORMATION)

(TOMATO PRODUCERS) ORDER, 1979

Made 14th November 1979

Coming into Operation 16th November 1979

THE STATES COMMITTEE FOR HORTICULTURE, in exercise of the powers conferred upon it by section two of the Horticultural Industry (Statistical Information) Ordinance, 1964 (a), and of all other powers enabling it in that behalf, hereby orders:-

1. Every occupier of land used for the production in glasshouses of tomatoes intended for export (hereinafter referred to as "the designated land") shall not later than the seventh day of December in each year furnish to the Committee for Horticulture (hereinafter referred to as "the Committee") on the form provided for that purpose by the Committee (hereinafter referred to as "the form") the information set out in the next succeeding section in respect of every glasshouse on the designated land and in respect of the period or periods as shall be specified in the form.

2. The Information required to be furnished to the Committee by every occupier of the designated land in accordance with the provisions of the last preceding section is as follows:-

(a) the area of -

- (i) every glasshouse on the designated land;
- (ii) every glasshouse on the designated land in which tomatoes for export are to be cultivated during the period specified in the form;
- (iii) every glasshouse on the designated land in which crops other than tomatoes are to be cultivated during the period specified in the form; and
- (iv) every glasshouse on the designated land in which no crops are to be cultivated during the period specified in the form;

(b) the varieties of tomatoes to be cultivated in the glasshouses on the designated land during the period specified in the form and the area of glasshouses to be used for the cultivation of each such variety; and

- (c) details of the cropping plan for the tomatoes to be cultivated in the glasshouses on the designated land during the period specified in the form, such cropping plan to be set out in the manner specified in the form.

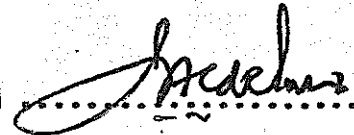
3. The Interpretation (Guernsey) Law, 1948 (b) shall apply to the interpretation of this Order as it applies to the interpretation of an enactment.

4. This Order may be cited as the Horticultural Industry (Statistical Information) (Tomato Producers) Order, 1979.

5. This Order shall come into force on the sixteenth day of November, nineteen hundred and seventy-nine.

Explanatory Note

(This Note forms no part of the Order but is intended to indicate its general purport).

The purpose of this Order is to enable the States Committee for Horticulture to obtain from tomato producers details of the areas of tomatoes grown or to be grown in glasshouses by such producers including the areas of each variety of tomatoes.
