The Parking Places (Amendment) (No.2) Order, 1981

Coming into force on the 7th day of December, 1981

THE ISLAND POLICE COMMITTEE, in exercise of the powers conferred upon it by section one of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a) hereby orders:-

1. The Parking Places Order, 1968, as amended(b), is hereby further amended as follows:-

- (a) In paragraph (c) of section nine thereof the word, letters and figures "D90 and D110" are repealed and the word, letters and figures "D90, D110, D119 and D120" are substituted therefor;
- (b) in paragraph (e) of section nine thereof the word, letters and figures "D107 and D108" are repealed and the word, letters and figures "D107, D108 and D121" are substituted therefor;
- (c) the entry relating to disc parking place No.D4 in the third column of Part I of the First Schedule thereto is repealed and the entry "The east side of the road between a parking sign placed by the front wall of Hirzel House near the top of Smith Street and a parking sign placed as near as may be to the northern end of Hirzel House." is substituted therefor;
- (d) the entry relating to disc parking place No.D40 in the third column of Part I of the First Schedule thereto is repealed and the entry "The east side of the road between a parking sign placed as near as may be to its junction with Grange Road and a parking sign placed as near as may be opposite to its southern junction with Monument Garden Road." is substituted therefor;
- (e) the entry relating to disc parking place No.D42 in the third column of Part I of the First Schedule thereto is repealed and the entry "The south side of the road between a parking sign placed as near as may be to its junction with Upland Road and a parking sign placed as near as may be to the eastern extremity of disc parking place

- (f) the entry relating to disc parking place No.D44 in the third column of Part I of the First Schedule thereto is repealed and the entry "The north side of the road between a parking sign placed as near as may be to the western entrance to Candie Gardens and a parking sign placed as near as may be to its junction with Saint Julian's Avenue." is substituted therefor;
- (g) the entry relating to disc parking place No.D89 in the third column of Part I of the First Schedule thereto is repealed and the entry "The north side of the road between a parking sign placed as near as may be to the western gate of the Fire Station at Town Arsenal and a parking sign placed as near as may be to its junction with Brock Road." is substituted therefor;
- (h) immediately after the entries relating to disc parking place No.D118 in each of the columns of Part I of the First Schedule thereto there are inserted respectively the entries in each of the columns of the First Schedule to this Order;
- (i) immediately after the entries relating to approved parking place No.A59 in each of the columns of Part II of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Second Schedule to this Order;
- (j) the entries relating to approved parking place No.MB10 in each of the columns of Part III of the First Schedule thereto are repealed.

2. This Order may be cited as the Parking Places (Amendment) (No.2) Order, 1981.

3. This Order shall come into force on the seventh day of December, nineteen hundred and eighty-one.

FIRST SCHEDULE

Section one (h)

- "D119 Les Amballes, Saint Peter Port. The west side of the road between a parking sign placed as near as may be to the premises known as No.3 Kingston Terrace and a parking sign placed as near as may be to the Auctioneer's premises at the northern end of the road.
- D120 Hirzel Street, Saint Peter Port. The west side of the road between a parking sign placed at the northern extremity of disc parking place No.D3 and a parking sign placed as near as may be to the gateway to the premises of the Old Government House Hotel.
- D121 Monument Road, Saint Peter Port. The west side of the road between a parking sign placed as near as may be to its junction with Arsenal Road and a parking sign placed as near as may be to its junction with Candie Road. "

SECOND SCHEDULE

Section one (i)

- "A60 Well Road, Saint Peter Port. The north side of the road between a parking sign placed as near as may be to its junction with Paris Street and a parking sign placed as near as may be to its junction with Gategny Esplanade.
- A61 Saint John's Road, Saint Peter Port. The north side of the road between a parking sign placed as near as may be to its junction with Les Amballes and a parking sign placed as near as may be to its junction with Rouge Rue.
- A62 Coronation Road, Saint Peter Port. The east side of the road between a parking sign placed as near as may be to its junction with Fosse André and a parking sign placed as near as may be to its junction with Elm Grove.
- A63 Rouge Huis Avenue, Saint Peter Port. The west side of the road between a parking sign placed as near as may be to its junction with Elm Grove and a parking sign placed as near as may be to its junction with Brock Road.
- A64 Brock Road, Saint Peter Port. The east side of the road between a parking sign placed as near as may be to the northern gate of the Ebenezer Methodist Church and a parking sign placed as near as may be opposite to its junction with Rosaire Avenue.
- A65 Rosaire Avenue, Saint Peter Port. The north side of the road between a parking sign placed as near as may be to its junction with Brock Road and a parking sign placed as near as may be to its junction with the Gibauderie.

A66 Upper Mont Arrivé,
Saint Peter Port.

The east side of the road between a parking sign placed as near as may be to the Post Office collecting box to the south of its junction with Rouge Rue and a parking sign placed as near as may be opposite its junction with Guelles Road.

A67 New Paris Street, Saint
Peter Port.

The east side of the road between a parking sign placed as near as may be to its junction with Piette Road and a parking sign placed as near as may be to its junction with Paris Street. "
