**The Parking Places (Amendment) (No.3) Order, 2004**

Made----- 17<sup>th</sup> July 2004

Coming into operation on----- 19<sup>th</sup> July 2004

**THE ENVIRONMENT DEPARTMENT**, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1991, as amended(b) is further amended in accordance with Articles 2 to 12 of this Order.
2. In Part B of Schedule 1, in the third column of the entry relating to Disc Parking Place DB10a, the words “ but excluding Approved Parking Place Nos. AA83 and AC29.” are inserted immediately following the word “road”.
3. In Part B of Schedule 1, the entry relating to Disc Parking Place No. DB12 is deleted.
4. In Part C of Schedule 1, for the entry relating to Disc Parking Place No. DC20 substitute the following entry:-

DC20	St George’s Esplanade	The south-west side of the portion of the road between the junctions with Piette Road and Le Bouet, within the limits indicated by signs, but excluding Approved Parking Places Nos. AB17 and AB31 and excluding Disc Parking Place No. DE29.

5. In Part E of Schedule 1, for the entry relating to Disc Parking Place No. DE29 substitute the following entry:-

DE29	St George's Esplanade	The south-west side of the portion of the road, between Piette Road and 'The Grapevine', but excluding Approved Parking Place No. AB17.

6. In Part A of Schedule 2, immediately following the entry relating to Approved Parking Place No. AA82, insert the following entries:-

AA83	York Avenue	On the eastern side of the road between the junctions with Route Isabelle and De Beauvoir within the limits indicated by signs.
AA83	St James Street	The portion of the road on the north side of St James Street, within the limits indicated by signs as being reserved for permit holders only.
AA84	Rue du Manoir	The portion of road at the northern end near to the junction of St James Street within the limits indicated by signs as being reserved for permit holders only.

7. In Part A of Schedule 2, in the third column of the entry relating to Approved Parking Place No. AA47, the words " but excluding Approved Parking Place Nos. AC15, AC28 and AC28a." are inserted immediately following the word "estates".

8. In Part A of Schedule 2, in the third column of the entry relating to Approved Parking Place No. AA57, the words " but excluding Approved Parking Place Nos. AC1a, AC21, AC26 and AC30." are inserted immediately following the word "estates".

9. In Part B of Schedule 2, for the entry relating to Approved Parking Place No. AB17 substitute the following entry:-

AB17	St Georges Esplanade	On the south-west side of the road to the north-west of the junction with Piette Road

10. In Part B of Schedule 2, immediately following the entry relating to Approved Parking Place No. AB30, insert the following entry;

AB31	St Georges Esplanade	The portion of road on the south-west side to the north of the junction with Le Bouet within the limits indicated by signs.
------	----------------------	---

11. In Part C of Schedule 2, the entry relating to Approved Parking Place No. AC7c is deleted.


12. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC27, insert the following entries:-

AC28	La Vrangue Estate	The portion of road as near as may be to No. 16, within the limits indicated as being reserved for persons in possession of a disabled person's badge.
AC28a	La Vrangue Estate	The portion of road as near as may be to No. 30, within the limits indicated as being reserved for persons in possession of a disabled person's badge.
AC29	St James Street	The portion of the north side of the road within the limits indicated as being reserved for persons in possession of a disabled person's badge.
AC30	Rue Jehannet, St Martin's	The portion of road as near as may be to No. 51, within the limits indicated as being reserved for persons in possession of a disabled person's badge.

13. This Order may be cited as the Parking Places (Amendment) (No.3) Order, 2004.

14. This Order shall come into force on ~~17<sup>th</sup>~~ July, 2004.
