The Parking Places (Amendment) (No. 3) Order, 1993

Made on the 26th November, 1993
Coming into force on the 27th November, 1993

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a), hereby orders:-

1. The Parking Places Order, 1991, as amended (b), is amended further in accordance with Articles 2 to inclusive of this Order.

2. In Article 9. -

(a) paragraph (h), delete the letter "G" and insert the letter "H";

(b) paragraph (h)(i), immediately after the figures "10.00" there is inserted "on any day other than a Saturday, Sunday or Bank Holiday";

(c) paragraph (h)(ii), immediately before the words and figures there is inserted "in disc parking places DH2, DH3, DH4 or DH5";

(d) immediately after paragraph (h)(ii) there is inserted the following additional paragraph:-

"(iii) in disc parking place DH1 for a continuous period greater than 2 hours ending between 10.00 and 18.00."

3. In Part B of Schedule 1 the entry relating to disc parking place No. DB20 is repealed.

4. In Part C of Schedule 1 -

(a) in the third column of the entry relating to disc parking place No. DC23 delete the words and figure "and AD8";

(b) immediately after the entry relating to disc parking place No. DC23 there is inserted the following additional entry:

| No | Situation | Disc Parking Place |
|--------|---------------------------|--|
| "DC23a | South Quay, Saint Sampson | The south side of the road between a point opposite the Clock Tower and the junction with New Road, but excluding Disc Parking Place No. DH1." |

(c) immediately after the entry relating to disc parking place No. DC24 there is inserted the following additional entry:

| No | Situation | Disc Parking Place |
|--------|------------------------------------|---|
| "DC24a | The Bridge, Vale and Saint Sampson | The east side of the road within the limits indicated by signs, but excluding Approved Parking Place No. AD8" |

5. In Part C of Schedule 2 -

(a) immediately before the entry relating to approved parking place No. AC1 there is inserted the following additional entry:

| No | Situation | Approved Parking Place |
|-------|-----------------------------------|--|
| "AC1a | Rue Jehannet Estate, Saint Martin | The portion of the road as near as may be to No. 16, indicated by signs as being reserved for persons in possession of a disabled person's badge." |

(b) immediately after the entry relating to approved parking place No. AC6 there is inserted the following additional entry:

| No | Situation | Approved Parking Place |
|-------|-----------------|--|
| "AC6a | Clairval Estate | The portion of the road as near as may be to No. 15, indicated by signs as being reserved for persons in possession of a disabled person's badge." ; |

6. In Part D of Schedule 2 delete the entry relating to approved parking place No. AD8 and replace with the following entry:

| No | Situation | Approved Parking Place |
|------|------------------|---|
| "AD8 | The Bridge, Vale | The portion of the east side of the road immediately to the north of Disc Parking Place No. DC24a." ; |

7. This Order may be cited as The Parking Places (Amendment) No.3 Order, 1993.

8. This Order shall come into force on the 27th November, 1993
