THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by sections 19 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990 (a), and of all other powers enabling it in that behalf, hereby orders:-

Amendment

1. For the Fourth Schedule to the Health Service (Payment of Authorised Appliance Suppliers) Regulations, 1990 (b) substitute the Schedule set out in the Schedule to these Regulations.

Citation

2. These Regulations may be cited as the Health Service (Payment of Authorised Appliance Suppliers) (Amendment) Regulations, 1991.

Commencement

3. These Regulations shall come into operation on the 1st day of September, 1991.

FOURTH SCHEDULE Regulation 3

Additional dispensing fees payable in respect of Part I or Part II appliances supplied on an appliance prescription claim form endorsed "URGENT" or "DISPENSED URGENTLY" in accordance with Regulation 3 of these Regulations; or Part III and Part IV appliances supplied on an appliance claim form endorsed "DISPENSED URGENTLY".

Time of supply	Dispensing fee
On any day, other than on a non-business day, between the time the premises of the authorised appliance supplier are closed for the supply of medical appliances and 11pm.	£ 12.70
On a non-business day, between 9am and 11pm, except whilst the premises are open for the purposes of any scheme prepared by the Authority under Part II of the Schedule to the Health Service (Authorised Appliance Suppliers) Regulations, 1990.	£ 16.05
On any day between 11pm and 9am of the next day or such earlier time at which the premises are opened for the supply of medical appliances (on any day except a non-business day).	£ 16.05

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport).

These Regulations amend the Health Service (Payment of Authorised Appliance Suppliers) Regulations, 1990 by increasing certain of the amounts payable to authorised appliance suppliers of medical appliances from 1st September, 1991.
