The Road Traffic (Prohibited and One-Way Streets) (No. 4)  
Regulations, 1989.

Made: 27 October, 1989.

Coming into operation: 1 November, 1989.


THE ISLAND POLICE COMMITTEE, in pursuance of the powers conferred upon it by Article X of the Ordinance entitled "Ordonnance relative au Trafic Vehiculaire en cette Ile" of 2 March, 1929 (a), and the Traffic Temporary Regulations Ordinance, 1950 (b), and of all powers enabling it in that behalf, hereby makes the following Regulations in order to ascertain the best method of regulating vehicular traffic in this Island:-

1. A person being in charge of a vehicle or an animal shall not, without the permission in writing of the Chief Officer, drive or ride that vehicle or cause or permit that animal to proceed along:-
  - a) Les Vardes or the upper section of Pied Des Vardes, St. Peter Port, from the junction with Les Godaines Avenue to the junction with George Road, otherwise than from south to north; or
  - b) George Road, St. Peter Port, from its junction with Pied Des Vardes to its junction with Colborne Road and Le Val Des Terres, otherwise than from north to south.
2. In these Regulations-

"animal" and "vehicle" have the meanings assigned to them by Article I of the Ordinance entitled "Ordonnance relative au Trafic Vehiculaire en cette Ile" of 2 March 1929;

"Chief Officer" means the Chief Officer of the Island Police Force.
3. These Regulations may be cited as the Road Traffic (Prohibited and One-Way Streets) (No. 4) Regulations, 1989.
4. These Regulations shall come into force on the 1 day of November, 1989 and shall continue in force until the 27 day of April, 1990.
5. The Road Traffic (Prohibited and One-Way Streets (No.1) Regulations, 1989, are hereby repealed.

EXPLANATORY NOTE

(This Note forms no part of the Regulations but is intended to indicate their general purport.)

The effect of these Regulations is that from 1 November, 1989 to 27 April, 1990, the lower section of Les Vardes and the upper part of Pied Des Vardes, St. Peter Port, will be a one-way street, with traffic being required to travel from the junction with Les Godaines Avenue towards the junction with George Road and, for the same period, George Road, St. Peter Port, will be a one-way street, with traffic being required to travel from the direction of Pied Des Vardes towards the junction with Colborne Road and Le Val Des Terres.

The upper section of Les Vardes between the junctions with Les Godaines Avenue and Colborne Road will revert to two-way traffic.
