**The Milk (Retail Prices) (Guernsey) Order, 2011**

<i>Made</i>	<i>13<sup>th</sup> September 2011</i>
<i>Coming into operation</i>	<i>2<sup>nd</sup> October 2011</i>

THE COMMERCE AND EMPLOYMENT DEPARTMENT, in exercise of the powers conferred on it by section 8(1) of the Milk (Control) (Guernsey) Ordinance, 1958<sup>a</sup> as amended,<sup>b</sup> and all other powers enabling it in that behalf, hereby orders:-

**Retail Price of Milk.**

1. The price to be charged for milk on sale by retail beginning on 2<sup>nd</sup> October 2011 shall be as follows:

full cream, low fat milk and skimmed milk	105 pence per litre
full cream, low fat milk and skimmed milk	59 pence per half litre
organic milk	78 pence per half litre.

**Interpretation.**

2 The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of this Order.

EXPLANATORY NOTE.

(This note is not part of the Regulations)

This Order changes the retail price to be charged for milk sold in litres and half litres from 2<sup>nd</sup> October 2011. This Regulation came into operation on 2<sup>nd</sup> October 2011.
