

GUERNSEY STATUTORY INSTRUMENT 1986 NO. 38

AMENDMENT NO.8 TO THE OPEN GENERAL IMPORT LICENCE OF 1984

THE BOARD OF ADMINISTRATION, in exercise of its powers under Section 3 of the Import and Export of Goods (Control)(Guernsey) Order 1978 (a) hereby further modifies the Open General Import Licence granted by the said Board on the 27th March 1984 (b), as follows:-

1. Article 1 (a) shall be amended as follows:-

- (1) In the definition of the "CEFTA Area", "Spain," shall be inserted after "Portugal,".
- (2) In the definition of the "Community Area", ",Portugal, Spain" shall be inserted after "Netherlands".
- (3) In the definition of the "Mediterranean Area", "Spain," shall be deleted.

2. In Article 4 (b), the words "in relation to which the country or territory mentioned in the fourth column is not marked by an asterisk (*)" shall be inserted after the words "European Community".

3. Schedule 1 shall be amended as follows:-

- (1) In Entry No. 11, "Romania" shall be inserted in the fifth column.
- (2) In Entry Nos. 74, 78, 84, 85, 90, 98, 109, 115, 123 and 148, "Turkey" shall be deleted from the fourth column.
- (3) In Entry Nos. 183, 185, 186, 187, 188, 189, 191, 193, 195, 198 and 201, "The Republic of South Africa" shall be inserted in the fourth column.
- (4) In Entry Nos. 183, 184 and 185, "*" shall be deleted after "Czechoslovakia".
- (5) The following Entries shall be inserted after Entry No. 184:

- (6) In Entry Nos. 186, 187, 188, 189, 191, 193, 195, 198 and 201, "Korea (North)*" shall be inserted in the fourth column.
- (7) In Entry No. 201, "Czechoslovakia*" shall be deleted from the fourth column.

- 8) In Entry No. 213, exclusion (c) shall be redesignated (d), exclusion (d) shall be redesignated (e) and exclusion (e) shall be redesignated (c).
- (9) Entry Nos. 9A, 11A, 181, 203, 204, 205, 206, 207, 214 and 215 shall be deleted.

4. Schedule 2 shall be amended as follows:-

(1) The following Entries shall be inserted:

- (4) In Entry Nos. 1124, 1126 and 1127 the words "All countries and territories other than those in the Community Area" in the fourth column shall be deleted and replaced by "Bulgaria*; Hungary*; Poland*; Romania*; all countries and territories other than the foregoing and other than those in the Community Area".

- (5) In Entry Nos. 1125A, 1128 and 1129 the words "All countries and territories other than Brazil, Spain and those in the Community Area" in the fourth column shall be deleted and replaced by "Bulgaria*: Hungary*: Poland*: Romania*: all countries and territories other than the foregoing and other than those in the Community Area".
- (6) In Entry No. 1130, the words "All countries and territories other than Brazil, Spain and those in the Community Area" in the fourth column shall be deleted and replaced by "Bulgaria*: Czechoslovakia*: Hungary*: Poland*: Romania*: all countries and territories other than the foregoing and other than those in the Community Area".
- (7) Entry Nos. 1103, 1121A, 1123A, 1125, 1125B, 1126A, 1127A, 1128A, 1129A, 1131 and 1132 shall be deleted.
5. This amendment shall come into operation on the 10th day of December, 1986.
