The Social Insurance (Contributions) (Amendment)
Regulations, 1991

Made 9th October, 1991

Laid before the States

Coming into operation 1st January, 1992

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section 20 and section 116 of the Social Insurance (Guernsey) Law, 1978, as amended^(a), hereby orders:-

Amendment

1. The Seventh Schedule to the Social Insurance (Contributions) (Guernsey) Regulations, 1978, as amended^(b), is substituted by the Schedule set out in the Schedule to these Regulations.

2. In paragraph (6) of regulation 11, for the words "Seven and one half per centum of the current lower weekly earnings limit" is substituted

"the product of such percentage as shall for the time being be determined by the States by ordinance under subsection (2) of section six of the Law and the current lower weekly earnings limit".

Repeal

2. The Social Insurance (Contributions) (Amendment) Regulations, 1990^(c), are repealed.

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation

4. These Regulations may be cited as the Social Insurance (Contributions) (Amendment) Regulations, 1991.

Commencement

5. These Regulations shall come into force on the 1st day of January, 1992.

EXPLANATORY NOTE
