The Health Service (Medical Appliances) (Amendment) (No. 3) Regulations, 2005

THE SOCIAL SECURITY DEPARTMENT, in exercise of the powers conferred upon it by sections 15, 16, 18 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990, as amended^(a), hereby orders:-

Amendment

1. For the Third Schedule to the Health Service (Medical Appliances) Regulations, 1990, as amended^(b) substitute the Schedule set out in the Schedule to these Regulations.

Repeal

2. The Health Service (Medical Appliances) (Amendment) Regulations, 2004^(c) is hereby repealed.

Interpretation

3. The Interpretation (Guernsey) Law, 1948 applies to the interpretation of these regulations as it applies to the interpretation of a Guernsey enactment.

Citation

4. These Regulations may be cited as the Health Service (Medical Appliances) (Amendment) (No. 3) Regulations, 2005.

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport).

These Regulations further amend the Health Service (Medical Appliances) Regulations, 1990, as amended, by increasing the charges payable to authorised appliance suppliers in Guernsey and Alderney by persons supplied with Part I, II or III medical appliances who are not exempt from such charges.
