



The Parking Places (Amendment) Order, 2001

Made ----- 26th October 2001

Coming into operation on-----29th October 2001

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1991, as amended(b) is further amended in accordance with Articles 2 to 6 inclusive of this Order.
2. In Part B of Schedule 1, for the entry relating to Disc Parking Place No. DB6 substitute the following entry-

"DB6	Victoria Road	The south side of the portion of the road between the junction of Lower Vauvert and Disc Parking Place No. DC10."

3. In Part C of Schedule 1, for the entry relating to Disc Parking Place No. DC10 substitute the following entry-

"DC10	Victoria Road	The south-west side of the road between Disc Parking Place No. DB6 and the junction with Valnord."

4. In Part D of Schedule 1, for the entry relating to Disc Parking Place No. DD17 substitute the following entry -

"DD17	Upland Road	The east side of the portion of the road between Approved Parking Place No. AB15a and the south part of Monument Gardens Road."

5. In Part C of Schedule 2, for the entry relating to Approved Parking Place No. AC1d, substitute the following entry -

"AC1d	Saumarez Mill Estate, St Martin	The portion of road as near as may be to No. 17, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

6. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC10, the following entries are inserted-

"AC11	Bas Courtils Estate,	The portion of road as near as may be to No. 30, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."
"AC12	Rue Jehannet Estate, St Martin	The portion of road as near as may be to No. 8, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."
"AC13	Rougeval Estate, St Peter Port	The portion of road as near as may be to No. 18, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."
"AC14	New Place, St Peter Port	The portion of road as near as may be to Nos. 5-6, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."
"AC15	La Vrangue Estate, St Peter Port	The portion of road as near as may be to No. 38, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

7. This Order may be cited as the Parking Places (Amendment) Order, 2001.

8. This Order shall come into force on the twenty-ninth day of October 2001.
