1. The First, Second and Fourth Schedules of the Post Office (Inland Post) Order, 1983 as amended (b), are repealed and the Schedules set out in the First, Second and Third Schedules to this Order are substituted therefor.

2. This Order may be cited as the Post Office (Inland Post) (Amendment) (No. 4) Order, 1989.

Commencement.

3. This Order shall come into force on the 1st day of January, 1990.

9. Redirection by the States Post Office.

Redirection of postal packets from their original address to the same addressee at another address in pursuance of the addressee's application:-
