**The Social Insurance (Benefits) (Amendment) Regulations, 2007**

Made ... .. 19th December, 2007  
Laid before the States ... ..  
Coming into operation ... .. 7th January, 2008

**THE SOCIAL SECURITY DEPARTMENT**, in exercise of the powers conferred upon it by sections 36, 39 and 116 of the Social Insurance (Guernsey) Law, 1978, as amended<sup>(a)</sup>, and of all other powers enabling it in that behalf, hereby orders:-

**Amendment**

1. In the Social Insurance (Benefits) Regulations, 2003, as amended<sup>(a)</sup> insert the following Part after Part V:

**“PART V(I)  
OTHER BENEFITS**

*Travelling allowance grant*

**50A.** (1) For the purposes of sections 36(1)(b)(i) and 36(1)(b)(ii) of the Law, the destinations to which a Travelling Allowance Grant may be awarded are limited as follows –

- (a) from Guernsey or Alderney to the United Kingdom, Jersey or France;
- (b) from Alderney to Guernsey.”

2. The five schedules to the Social Insurance (Benefits) Regulations, 2003 are revoked and replaced by the five schedules set out in the Schedule to these Regulations.

### **Citation**

4. These Regulations may be cited as the Social Insurance (Benefits) (Amendment) Regulations, 2007.

### **Commencement**

5. These Regulations shall come into force on 7th January, 2008.

### **EXPLANATORY NOTE**

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations:

(a) limit the destinations for which a travelling allowance grant may be awarded to Guernsey, Jersey, France and the United Kingdom.

(b) amend the schedules to the Social Insurance (Benefits) Regulations, 2003 and prescribe the reduced rates payable from 7th January 2008 to claimants who do not satisfy the conditions for entitlement to payment of the maximum rate of benefit.
