The Parking Places (Amendment) Order, 1997

Made on the ... .. 10th February, 1997  
Coming into force on the ... 10th February, 1997

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a), hereby orders:-

1. The Parking Places Order, 1991, as amended (b), is further amended in accordance with Articles 2 to 6 inclusive of this Order.

2. In Part B of Schedule 1 -

(a) immediately after the entry relating to disc parking place No. DB6, insert the following entry-

No.	Situation	Disc Parking Place
DB6a	La Couperderie	The south side of the portion of the road to the west of the junction with Cordier Hill, but excluding Disc Parking Place No. DE13."

(b) in the third column of the entry relating to disc parking place No. DB22, delete "Place AC8" and substitute "Places Nos. AB22c and AC8";

(c) in the third column of the entry relating to disc parking place No. DB24, delete "Place No. AC9" and substitute "Places Nos. AB22d and AC9".

3. In Part D of Schedule 1, immediately after the entry relating to disc parking place No. DD5, insert the following entry-

No.	Situation	Disc Parking Place
" DD5a	Havelet	The south side of the portion of the road opposite and below the entrance to Hotel de Havelet within the limits indicated by signs."

4. In Part E of Schedule 1 -

- (a) in the third column of the entry relating to disc parking place No. DE13, immediately after "Cordier Hill" insert ", but excluding Disc Parking Place No. DB6a";
- (b) in the third column of the entry relating to disc parking place No. DE26, delete ", but excluding Approved Parking Place No. AC5";
- (c) in the third column of the entry relating to disc parking place No. DE27, immediately after "signs" insert ", but excluding Approved Parking Place No. AC5".

5. In Part B of Schedule 2, immediately after the entry relating to approved parking place No. AB22b, insert the following entries -

No.	Situation	Approved Parking Places
" AB22c	The Bridge, St. Sampson	The west side of the portion of the road immediately to the north of its junction with Rue de Commerce.
AB22d	The Bridge, Vale	The west side of the portion of the road immediately to the north of its junction with Bridge Avenue."

6. In Part C of Schedule 2 -

(a) immediately after the entry relating to approved parking place No. AC1a, insert the following entry -

No.	Situation	Approved Parking Place
" AC1b	Les Vardes	The portion of the west side of the road to the north of its junction with Colborne Road within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

(b) for the entry relating to approved parking place No. AC5 substitute the following entry -

No.	Situation	Approved Parking Places
" AC5	Paris Street	The portion of the north side of the road within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."


(c) immediately after the entry relating to approved parking place No AC7, insert the following entry -

No	Situation	Approved Parking Places
" AC7a	Les Genats, Castel	The portion of the south/east side of the road as near as may be to No. 19 within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

7. This Order may be cited as The Parking Places (Amendment) Order, 1997.

8. This Order shall come into force on the 10th February, 1997
