
GUERNSEY STATUTORY INSTRUMENT

The Social Insurance (Classification)(Amendment)(Guernsey) Regulations, 1978

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section one, section eight and section seventy-seven of the Social Insurance (Guernsey) Law, 1964, and of all other powers enabling it in that behalf, hereby orders :-

Amendment of Part 1 of the First Schedule to the principal regulations

1. In Part 1 of the First Schedule to the Social Insurance (Classification) (Guernsey) Regulations, 1964 (hereafter in these regulations referred to as "the principal regulations") there shall be inserted -

- (a) in column (A) thereof, the following paragraph -
" 5. Employment as a minister of religion, not being employment under a contract of service. ";
- (b) in column (B) thereof, the following paragraph -
" 5. Any person in employment specified in paragraph 5 of column (A) whose remuneration in respect of that employment (disregarding any payment in kind) does not consist wholly or mainly of stipend or salary."

Amendment of Third Schedule to the principal regulations

2. In the Third Schedule to the principal regulations there shall be inserted -

(a) in column (A) thereof, the following paragraphs -

" 5. Employment as a minister of the Church of England, not being employment under a contract of service.

6. Employment as a minister of religion, not being employment -

(a) as a minister of the Church of England;

(b) under a contract of service; or

(c) specified in paragraph 5 of column (B) of Part 1 of the First Schedule to these regulations. ";

(b) in column (B) thereof, the following paragraphs -

" 5. The Church Commissioners for England.

6. The person responsible for the administration of the fund from which the remuneration in respect of the employment is paid. "

Citation and Commencement

3.(1) These regulations may be cited as the Social Insurance (Classification) (Amendment)(Guernsey) Regulations, 1978, and these regulations and the Social Insurance (Classification)(Guernsey) Regulations, 1964 and 1966, may be cited together as the Social Insurance (Classification)(Guernsey) Regulations, 1964 to 1978.

(2) These regulations shall come into force on the third day of April, nineteen hundred and seventy-eight.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport)

Regulation one amends the principal regulations to the effect that a minister of religion whose remuneration consists wholly or mainly of stipend or salary and who is not employed under a contract of service shall be classed as an employed person for the purposes of the Social Insurance (Guernsey) Law, 1964. Regulation two defines the responsible employer of a minister of religion who is an employed person not being employed under a contract of service.
