The Social Insurance (Classification) (Amendment) Regulations, 2000

Made 30th March, 2000.

Laid before the States

Coming into operation 1st April, 2000.

THE GUERNSEY SOCIAL SECURITY AUTHORITY, in exercise of the powers conferred upon it by section 1 of the Social Insurance (Guernsey) Law, 1978, as amended^a, and of all the powers enabling it in that behalf, hereby orders:-

Amendment

1. The Social Insurance (Classification) (Guernsey) Regulations, 1978, as amended^b are further amended as follows:

(a) in regulation 1(2), for “regulation two of the Social Insurance (Contributions) (Guernsey) Regulations, 1978.” there is substituted “regulation 2 of the Social Insurance (Contributions) Regulations, 2000.”;

(b) in the First Schedule, paragraphs 9 and 10 are deleted and the following substituted

“

9. Any employment or employments (other than any employment or employments under a contract of service) where the insured person has applied to the Authority to pay a Class 2 contribution under section 6(3) of the Law, and the Authority is satisfied that the insured person would, but for the provision of this paragraph, be liable to pay a Class 2 contribution of an amount less than the product of such percentage as shall for the time being be determined by the States by Ordinance under section 6(2) of the Law and the current lower weekly earnings limit	9. Any person engaged full-time in any employment or employments specified in paragraph 9 of column (A).
