**The Social Insurance (Widow's Benefit and Old Age Pensions) (Amendment)
Regulations, 1999.**

Made 2nd December, 1999.

Laid before the States

Coming into operation 3rd January, 2000.

THE GUERNSEY SOCIAL SECURITY AUTHORITY, in exercise of the powers conferred upon it by sections 11(2) and 39 of the Social Insurance (Guernsey) Law, 1978, as amended^a, hereby orders:-

Amendment

1. (1) For regulation 3 of the Social Insurance (Widow's Benefit and Old Age Pensions) (Guernsey) Regulations, 1978, as amended^b ("the principal regulations") there is substituted the following:

"Credits for widowed parents allowance

3. A Class 3 contribution shall be credited to a man for the purposes of entitlement to an old age pension or to death grant only in respect of every week for the whole or any part of which widowed parent's allowance is payable to him."

(2) In regulation 6(2) of the principal regulations the expression "or (3)", immediately following "column (2)" is deleted.

(3) Immediately after regulation 6(2), there is inserted the following:

" (3) For the purposes of paragraph (1), the reduced rate of survivor's grant payable shall be the reduced rate in column (2) of the Third Schedule which appears opposite the yearly average of reckonable contributions paid or credited as shown in column (1)."

(4) For the First Schedule to the principal regulations there is substituted the First Schedule to these regulations.

(5) For the Second Schedule to the principal regulations there is substituted the Second Schedule to these regulations.

(6) immediately following the Second Schedule to the principal regulations there is inserted the Third Schedule to these regulations.

Citation

2. These regulations may be cited as the Social Insurance (Widow's Benefit and Old Age Pensions) (Amendment) Regulations, 1999.

Commencement

3. These regulations shall come into force on 3rd January, 2000.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These regulations provide for the crediting of a contribution to a man receiving widowed parent's allowance, specify the reduced rates of survivor's grant payable where the contribution conditions are not met in full, and increase the rates of the remaining benefits in line with the general increase of benefit rates approved by the States on 29th September 1999.
