**The Social Insurance (Classification) (Amendment)
(Guernsey) Regulations, 2011**

THE SOCIAL SECURITY DEPARTMENT, in exercise of the powers conferred upon it by sections 1 and 116 of the Social Insurance (Guernsey) Law, 1978^a, as amended and of all other powers enabling it in that behalf, hereby orders:-

Amendment.

1. In Part III of the First Schedule to the Social Insurance (Classification) (Guernsey) Regulations, 1978, as amended^b, immediately after paragraph 19, insert the following:-

Interpretation.

2. (1) Except where the context otherwise requires, any reference in these Regulations to any enactment or regulations shall be construed as including a reference to that enactment or those regulations, as the case may be, as amended, repealed, replaced, revoked, extended or applied, by or under any other enactment or by any other regulations.


(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of these Regulations as it applies to the interpretation of a Guernsey enactment.

Citation, commencement and extent.

3. (1) These Regulations may be cited as the Social Insurance (Classification) (Amendment) (Guernsey) Regulations, 2011 and shall come into force on the 1st January, 2012.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the Social Insurance (Classification) (Guernsey) Regulations, 1978 to provide that persons employed as Jurats of the Royal Court of Guernsey shall be treated as non-employed persons in respect of that employment, and that any such employment shall be disregarded. In practice, this means that fees received by Jurats for carrying out their duties shall be treated as income, not earnings, and only included in the calculation of a non-employed person's liability.

These Regulations come into force on the 1st January 2012.
