

**Mooring Charges Regulations, 2011**

No. 58

*Made**29 December, 2011**Coming into operation**1 January 2012**Laid before the States*

**THE PUBLIC SERVICES DEPARTMENT**, in exercise of the powers conferred upon it by sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007<sup>a</sup>, and all other powers enabling it in that behalf, hereby makes the following regulations:-

**Charges.**

1. (1) The charges set out in the Schedule to these Regulations shall have effect.

(2) Subject to subsection (3), the charges as prescribed by the Mooring Charges (No.2) Regulations, 2010<sup>b</sup>, shall cease to have effect.

(3) The ceasing of effect of the charges referred to in subsection (2) is without prejudice to any right, privilege, obligation or liability acquired, accrued or incurred in respect of those charges.

**Interpretation.**

2. (1) In these regulations, unless the context requires otherwise –

"**Area A**" means the area(s) more particularly shown and delineated on the Moorings Map and thereon marked "Area A",

"**Area B**" means the area(s) more particularly shown and delineated on the Moorings Map and thereon marked "Area B",

"**Area C**" means the area(s) more particularly shown and delineated on the Moorings Map and thereon marked "Area C",

"**boat**" means anything for the conveyance by water of human beings or of property,

"**casual use**" means use by a boat whose owner has allocated a temporary mooring in circumstances appearing to the Department to be of an adhoc nature, or for over-wintering,

"**Department**" means the States Public Services Department,

"**fishing boat**" means a boat of which the owner has satisfied the Department –

- (a) that the boat is used wholly or principally for catching fish for profit as a business, and
- (b) that his income is derived wholly or mainly from such business,

**"house boat"** means a registered boat which is used for the purpose of human habitation (including persons sleeping on board) for any continuous period greater than a period of twenty-eight days or periods, which in the aggregate, amount to a period greater than a period of twenty-eight days during any calendar year,

**"Moorings Map"** means either the St. Peter Port moorings map or the St. Sampson's moorings map, as the case may be,

**"overall beam"** means the greatest breadth of the boat including anything fixed to it but excluding portable fenders,

**"overall length"** includes the boat and anything fixed to it,

**"registered boat"** means a boat for the time being registered under the provisions of the Boats and Vessels (Registration, Speed Limits and Abatement of Noise") Ordinance, 1970<sup>c</sup>,

**"registered fishing boat"** means a fishing boat which is a registered boat,

**"square foot"** shall be calculated by multiplying the overall length of the boat by its overall beam, and

- (a) any part of the overall length of the boat which is less than one foot shall be deemed to be one foot, and

- (b) any part of the overall beam of the boat which is –
  - (i) less than six inches shall be disregarded, and
  - (ii) more than six inches but less than one foot shall be deemed to be six inches, and

"**St. Peter Port moorings map**" means the map signed by the Bailiff on 10 March, 2010, and lodged at the Greffe, and

"**St. Sampson's moorings map**" means the map signed by the Bailiff on 10 March, 2010, and lodged at the Greffe.

(2) The Interpretation (Guernsey) Law, 1948<sup>d</sup> applies to the interpretation of these regulations.

**Repeal.**

- 3. The Mooring Charges (No.2) Regulations, 2010<sup>e</sup> are repealed.

**Citation and commencement.**


- 4. These regulations may be cited as the Mooring Charges Regulations, 2011, and shall come into force on the 1<sup>st</sup> January 2012.

### EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations prescribe the mooring charges payable under section 2 of the Vessels and Speedboats (Compulsory Third-Party Insurance, Mooring Charges and Removal of Boats) (Guernsey) Law, 1972 (the "1972 Law"). These Regulations increase the existing mooring charges by approximately 4 per cent. Under the terms of the Fees, Charges and Penalties (Guernsey) Law, 2007, these charges may now be prescribed by regulations of the Public Services Department.

#### Legislative background.

Mooring charges payable under section 2 of the 1972 Law were originally made by way of Ordinance. Section 3 of the Harbours, Moorings and Pilotage (Fees and Dues) Law, 1986 amended section 2 of the 1972 Law to provide that the charges would be payable at such rates as the States may, from time to time, by Resolution prescribe. In 2001, the 1972 Law was further amended by section 2 of the Harbour Dues, Harbour Charges and Mooring Charges (Guernsey) (Amendment) Law, 2001 to provide that such a States Resolution could authorise the Board of the Public Services Department to amend the amount of those dues in respect of any specified twelve month period or periods by an amount not exceeding the change in the Guernsey Retail Price Index during such earlier twelve month period or periods as may be so specified.
