THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by sections 18 and 35 of the Health Service(Benefit)(Guernsey)Law, 1990(a), and of all other powers enabling it in that behalf, hereby orders:-

Amendments

1.(a) After Regulation 11(1) of the Health Service (Medical Appliances)Regulations,1990, as amended (b), insert -

" (1A) An authorised appliance supplier shall not supply Part III appliances under the Law for any person in a quantity exceeding that which is reasonably requisite for that person's treatment for a period of thirty days."

(b) For the Third Schedule to the Health Service (Medical Appliances) Regulations, 1990, as amended, substitute the Schedule set out in the Schedule to these Regulations.

2. These Regulations may be cited as the Health Service (Medical Appliances)(Amendment)(No.2) Regulations, 1991.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport).

These Regulations further amend the Health Service (Medical Appliances) Regulations, 1990, as amended, by increasing the charges payable to authorised appliance suppliers by persons supplied with medical appliances and by limiting the supply of Part III medical appliances on presentation of a medical appliance card to a quantity requisite for a period of thirty days.
