THE BOARD OF ADMINISTRATION, in exercise of its powers under Section 3 of the Import and Export of Goods (Control)(Guernsey) Order 1978 (a) hereby further modifies the Open General Import Licence granted by the said Board upon the 27th March 1984 (b), as follows:-

1. Schedule 1 shall be amended as follows:-

- (a) Entry Nos. 10, 183, 184, 185, 199 and 201 shall be deleted.
- (b) In Entry No. 35, "China" shall be deleted from the fifth column.
- (c) In Entry No. 55, "*" shall be inserted after "Czechoslovakia" in the fourth column.
- (d) In Entry Nos. 76, 99 and 111, "China" shall be inserted in the fourth column.
- (e) In Entry Nos. 77 and 103, "China" shall be deleted from the fourth column.
- (f) In Entry No. 116, "Thailand" shall be inserted in the fourth column.
- (g) In Entry No. 142, "Hong Kong" shall be inserted in the fourth column.
- (h) In Entry Nos. 186, 187, 188, 189, 191, 193 and 195, "Czechoslovakia*" shall be deleted from the fourth column.
- (i) In Entry No. 212, "Bulgaria; Czechoslovakia; German Democratic Republic and Berlin (East); Hungary; Poland;" shall be inserted in the fifth column.

2. Schedule 2 shall be amended as follows:-

- (a) Entry Nos. 1003, 1004, 1005, 1006, 1008, 1009, 1010, 1011, 1012, 1013, 1014, 1015, 1016, 1017, 1018, 1019, 1020, 1022, 1023, 1025, 1026, 1029, 1030, 1032, 1033, 1034, 1036, 1037, 1038, 1039, 1040, 1041, 1042, 1043, 1044, 1045, 1047, 1048, 1049, 1050, 1051, 1052, 1053, 1054, 1055, 1056, 1057, 1058, 1059, 1060, 1061, 1062, 1063, 1064, 1065, 1066, 1068, 1070, 1071, 1073, 1075, 1076, 1079, 1080, 1081, 1082, 1083, 1084, 1086, 1087, 1088, 1089, 1091, 1093, 1097, 1098, 1099, 1101, 1102, 1104, 1105, 1106, 1107, 1108, 1112, 1113, 1114, 1116, 1117, 1118, 1119, 1120 and 1121 shall be deleted.
- (b) In Entry Nos. 1027, 1028, 1069 and 1096, "China" shall be deleted from the fourth column.

3. This amendment shall come into operation on the nineteenth day of June, nineteen hundred and eighty-five.
