The Health Service (Pharmaceutical)(Payment of Approved Suppliers)
(Amendment)(Guernsey) Regulations, 1982

Made 5th March, 1982

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section twelve of the Health Service (Pharmaceutical)(Guernsey) Law, 1972, and of all other powers enabling it in that behalf, hereby orders:-

Amendment of regulation two of the principal regulations

1. Paragraph (1) of regulation two of the Health Service (Pharmaceutical)(Payment of Approved Suppliers)(Guernsey) Regulations, 1976(a), as amended (b) (hereinafter referred to as "the principal regulations"), is hereby further amended as follows:-

- (a) in sub-paragraph (b) thereof, the figures and words "22.75 per centum" are hereby repealed and the words "twenty-two per centum" are hereby substituted therefor;
- (b) in sub-paragraph (c) thereof, the figure and word "4 pence" are hereby repealed and the figures and word "4.5 pence" are hereby substituted therefor;
- (c) in sub-paragraph (d)(ii) thereof, the words "two pounds and fifty pence" are hereby repealed and the words "two pounds and eighty pence" are hereby substituted therefor:

- (d) in sub-paragraph (d)(iii) thereof, the words "twenty-six pence" are hereby repealed and the words "twenty-three pence" are hereby substituted therefor;
- (e) in sub-paragraph (e) thereof, the words "thirty pence" are hereby repealed and the words "thirty-three pence" are hereby substituted therefor.

Amendment of First Schedule to the principal regulations

2. The First Schedule to the principal regulations is hereby repealed and the Schedule set out in the First Schedule to these regulations is hereby substituted therefor.

Amendment of Second Schedule to the principal regulations

3. The Second Schedule to the principal regulations is hereby repealed and the Schedule set out in the Second Schedule to these regulations is hereby substituted therefor.

Repeals

4. The Health Service (Pharmaceutical)(Payment of Approved Suppliers)(Amendment)(No.2)(Guernsey) Regulations, 1976 (c), the Health Service (Pharmaceutical)(Payment of Approved Suppliers)(Amendment)(Guernsey) Regulations 1977, (d), the Health Service (Pharmaceutical)(Payment of Approved Suppliers)(Amendment)(Guernsey) Regulations, 1979, (e) and the Health Service (Pharmaceutical)(Payment of Approved Suppliers)(Amendment)(Guernsey) Regulations, 1980 (f) are hereby repealed.

Citation, collective title and commencement

5. (1) These regulations may be cited as the Health Service (Pharmaceutical)(Payment of Approved Suppliers)(Amendment)(Guernsey) Regulations, 1982.



Cachets, capsules, pills, tablet- triturates, lozenges, pastilles, suppositories, creams, ointments, enteric coating of tablets.	£1.40
Liquids prepared with aseptic technique	£1.40
Individually wrapped powders	£1.90

Additional dispensing fees payable in respect of pharmaceutical benefit supplied on medical prescriptions endorsed "URGENT" or "DISPENSED URGENTLY" in accordance with regulation three

(1) Time of supply	(2) Dispensing fee
On any day, other than a Sunday and a bank holiday, between the time the premises of the approved supplier are closed for the supply of pharmaceutical benefit and eleven o'clock in the afternoon	£3.60
On a Sunday or a bank holiday, between nine o'clock in the forenoon and eleven o'clock in the afternoon.	£3.60
On any day between eleven o'clock in the afternoon of the next previous day and nine o'clock in the forenoon or such earlier time at which the premises of the approved supplier are open for the supply of pharmaceutical benefit.	£7.30

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport).

These regulations further amend the Health Service (Pharmaceutical) (Payment of Approved Suppliers)(Guernsey) Regulations, 1976, by increasing certain of the amounts payable to approved suppliers in respect of drugs and medicines supplied by them under and in accordance with the Health Service (Pharmaceutical)(Guernsey) Law, 1972.
