

THE IMMIGRATION (CONTROL ON ENTRY)(EEC AND OTHER NON-COMMONWEALTH NATIONALS)(AMENDMENT) (GUERNSEY) RULES 1981

Made 10th March 1981

Laid before the States

Coming into Operation 11th March 1981

THE STATES BOARD OF ADMINISTRATION in exercise of the powers conferred upon it by sub-section (2) of section three of the Immigration Act 1971, as extended to the Bailiwick by the Immigration (Guernsey) Order 1972, hereby makes the following Rules:-

Amendments to Rules of 1973.

1. The Immigration (Control on Entry)(EEC and Other Non-Commonwealth Nationals)(Guernsey) Rules 1973, as amended (a), are hereby amended as follows:-

- (i) Nationals of Greece seeking to establish their identity and nationality on arrival in the Bailiwick of Guernsey may produce valid national identity cards instead of passports. Accordingly, Greece should be added to the list of countries in the footnote to paragraph 3 of the said Rules.
- (ii) The following paragraphs shall be inserted after paragraph 54 of the said Rules.

Nationals of Greece

- 54A. Paragraphs 54B - D apply only to nationals of Greece and their families and in relation to them override Parts II, III and IV to the extent indicated.
- 54B. A national of Greece who wishes to enter the Bailiwick of Guernsey in order to set up on business or work as a self-employed person is to be admitted without a work permit or other prior consent. He should normally be given leave to enter for a period of 6 months.
- 54C. When a national of Greece is admitted in accordance with paragraph 54B the member, of the family (as defined in paragraph 53) accompanying the person should be given leave to enter for the same period.
- 54D. Members of the family (as defined in paragraph 53) of a Greek national who has previously been admitted under paragraph 54B should be given leave to enter in order to join him in the Bailiwick of Guernsey.

Citation.

2. These Rules may be cited as the Immigration (Control on Entry)(EEC and Other Non-Commonwealth Nationals)(Amendment)(Guernsey)Rules 1981.
