

GUERNSEY STATUTORY INSTRUMENT

1992 No. 7

The Parking Places (Amendment) Order, 1992

Made on the 6th May, 1992

Coming into force 11th May, 1992

THE ISLAND TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a), hereby orders:-

1. The Parking Places Order, 1991, (b) is amended in accordance with Articles 2 to 10 inclusive of this Order.

2. In Article 5.(a) for "DE30 or DE31" substitute "DE31 or DE32".

3. In Part B of Schedule 1 -

(a) immediately after the entry relating to disc parking place No. DB3 there is inserted the following additional entry:

No	Situation	Disc Parking Place
"DB3a	La Coupée Lane	The portion of the lane indicated by parking signs."

(b) in the third column of the entry relating to disc parking place No. DB14 for "No. AA2" substitute "Nos. AA2 and AB20";

(c) the entry relating to disc parking place No. DB17 is repealed;

4. In Part C of Schedule 1, in the third column of the entry relating to disc parking place No. DC4 delete ", but excluding Approved Parking Place No. AB4";

5. In Part D of Schedule I -

(a) in the third column of the entry relating to disc parking place No. DD10 insert at the end of the words ", but excluding Approved Parking Place No. AB12a";

(b) S.I. 1991 No.40.

(b) in the third column of the entry relating to disc parking place No. DD13 insert at the end of the words ", but excluding Approved Parking Place No. AB14";

(c) the entry relating to disc parking place No. DD26 is confirmed.

6. In Part E of Schedule I -

(a) in the third column of the entry relating to disc parking place No. DE5 insert at the end of the words ", and Approved Parking Place No. AB4a";

(b) in the third column of the entry relating to disc parking place No. DE12 insert at the end of the words ",but excluding Approved Parking Place No. AB14";

(c) in the third column of the entry relating to disc parking place No DE13 delete "but excluding Approved Parking Place AB13";

(d) the entry relating to disc parking place No. DE21 is confirmed;

(e) the entry relating to disc parking place No. DE31 is confirmed and in the third column insert at the end of the words ", but excluding Approved Parking Place No. AB22a".

7. In Part A of Schedule 2, immediately after the entry relating to approved parking place No. AA51 there is inserted the following additional entry:

"AA51a | Courtil Ash"

8. In Part B of Schedule 2 -

(a) in the third column of the entry relating to approved parking place No. AB4 for "On the west and north sides" substitute "On the north side";

(b) immediately after the entry relating to approved parking place No. AB4 there is inserted the following additional entry:

No	Situation	Disc Parking Place
"AB4a	South Esplanade	The area designated by signs on the west side of the road immediately to the south of the northernmost junction with Les Echelons."

(c) immediately after the entry relating to approved parking place No. AB12 there is inserted the following additional entry:

No	Situation	Disc Parking Place
"AB12a	Valnord Hill	The portion of the north-west side of the road indicated by signs."

(d) immediately after the entry relating to approved parking place No. AB22 there is inserted the following additional entry:

No	Situation	Disc Parking Place
"AB22a	South Quay, Saint Sampson	The portion of the north side of the road indicated by signs near to the junction with Church Road."

9. In Part C of Schedule 2, in the third column of the entry relating to approved parking place No.AC7 insert at the end of the words "indicated by signs as being reserved for persons in possession of a disabled person's badge".


10. In Parts A, B, C, D and E of Schedule 1 and in Part A of Schedule 2, in the third column for the letters and figures as shown in column 2 below there are substituted the letters and figures as shown in column 3 below:

NOTE

This explanatory note forms no part of the Amendment Order. The purpose of this Amendment Order is:

(a) To regularise the decision of the Island Traffic Committee to change the parking at Le Crocq Pier from 10-hour to 5-hour and the decision to change the parking at Les Vauxlaurens from 5-hour to 10-hour which were omitted from the two press notices of 9th August and 19th November, 1991. Also to regularise the decision to schedule the parking at the South Quay on the north side of the road between Le Crocq Pier and Rue Dorey which were omitted from the press notice of 19th November.

(b) To include additional motor cycle parking at Valnord Hill, St. Peter Port and South Quay, St. Sampson.

(c) To relocate the section of motor cycle park from the west side of Les Echelons to the first two parking spaces on the west side of South Esplanade by the pedestrian crossing.

(d) To include the parking place in La Coupée Lane as 1-hour parking having been left out from the original Order.

(e) To include the estate roads of Courtil Ash as 23-hour approved parking having been left out from the original Order.

(f) To correct drafting errors in the original Order.
