The Parking Places (Amendment) Order, 1994

Made on the 20th July, 1994
Coming into force on the .. 1st August, 1994

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a), hereby orders:-

1. The Parking Places Order, 1991, as amended (b), is amended further in accordance with Articles 2 to 13 inclusive of this Order.

2. In Article 8 immediately after sub article (2) there is inserted the following sub article:

"(2.A.) A person shall not, without the permission in writing of the Committee, park a motor vehicle or a motor bicycle in approved parking place AA81 between 08.00 and 18.00 on any day except a Saturday, Sunday or Bank Holiday other than in accordance with the conditions on the parking signs."

3. In Article 9.(h)(ii) immediately after the letters and figure "DH2" there is inserted the letters and figure "DH2a".

4. In Article 12. -

(a) paragraph (a) delete the letters and numbers "AC1, AC2, AC7 or AC8" and insert "AC1a, AC1, AC2, AC6a, AC6b, AC7, AC8 or AC9";

(b) paragraph (b) is repealed.

5. In Part A of Schedule 1 delete the entry relating to disc parking place No. DA13 and substitute the following entry:

No	Situation	Disc Parking Place
"DA13	The Bridge, Vale and St. Sampson	The portions of the east side of the carriageway on the west side of the central reservation within the limits indicated by signs."

6. In Part B of Schedule 1 -

(a) the entries relating to disc parking places No. DB3 and DB3a are deleted;

(b) immediately after the entry relating to disc parking place No. DB16 there is inserted the following additional entry:

No	Situation	Disc Parking Place
"DB17	La Grande Rue, Saint Martin	The layby on the north-east side of the road immediately to the south east of the junction with Les Merriennes"

(c) in the third column of the entry relating to disc parking place No. DB19 substitute "Brock Road" for "Roland Road".

7. In Part C of Schedule 1 -

(a) in the third column of the entry relating to disc parking place No. DC3 substitute "1st June to 14th September" for "1st May to 31st October".

(b) immediately after the entry relating to disc parking place DC5 there are inserted the following additional entries:

No	Situation	Disc Parking Place
"DC5a	Cornet Street	Both sides of the portion of road between St. Peter's Court and Tower Hill within the limits indicated by parking signs.
DC5b	La Coupée Lane	The portion of the lane indicated by parking signs."

(c) in the third column of the entry relating to disc parking place No DC15 delete the words and figures "but excluding Disc Parking Place No. DA13";

(d) immediately after the entry relating to disc parking place No. DC31 there is inserted the following additional entry:

No	Situation	Disc Parking Place
"DC32	Trafalgar Road, Vale	The portion of the south side of the road immediately to the east of its junction with La Hougue Jehannet."

8. In Part D of Schedule 1 in the third column of the entry relating to disc parking place No. DD2 delete the words and substitute with "The north-west side of the portion of the road within the limits indicated by parking signs."

9. In Part E of Schedule 1 in the third column of the entry relating to disc parking place No. DE3 substitute "15th September to 31st May" for "1st November to 30th April".

10. In Part H of Schedule 1 immediately after the entry relating to disc parking place No. DH2 there is inserted the following additional entry:

No	Situation	Unloading Bay alternating Disc Parking Place
"DH2a	The Bridge, Saint Sampson	The portion of the south side of the road within the limits indicated by parking signs."

11. In Part A of Schedule 2 -

(a) in the third column of the entry relating to approved parking place No. AA20 delete the words and substitute with "Both sides of the portion of the road between the junctions with Rouge Rue and Guelles Road within the limits indicated by parking signs.";

(b) immediately after the entry relating to approved parking place No. AA29 there is inserted the following additional entry:

No	Situation	Approved Parking Place
"AA29a	Church Road, Saint Sampson	The north-west side of the portion of the road immediately to the north-east of the junction with New Road." ;

(c) in the third column of the entry relating to approved parking place No. AA31a substitute "portion" for "portions";

(d) in the third column of the entry relating to approved parking place No. AA40 insert "But excluding Approved Parking Place No. AC6b.";

(e) in the third column of the entry relating to approved parking place No. AA43 insert "But excluding Approved Parking Place No. AC6a.";

(f) in the third column of the entry relating to approved parking place No. AA66 insert "But excluding Approved Parking Place No. AB24.";

(g) immediately after the entry relating to approved parking place No. AA80 there is inserted the following additional entry:

No	Situation	Approved Parking Place
"AA81	Le Truchot	The portion of the south side of the road immediately to the east of the junction with Sir William Place."

12. In Part B of Schedule 2 -

(a) the entry relating to approved parking place No. AB22 is deleted and there is inserted the following substituted entry:

No	Situation	Approved Parking Place
"AB22	The Bridge, Saint Sampson	The portion of the south side of the road within the limits indicated by parking signs."

(b) immediately after the entry relating to approved parking place No. AB23 there is inserted the following additional entry:

No	Situation	Approved Parking Place
"AB24	Chemin Robin Estate, Castel	The portion of the parking area at the east end of the Estate within the limits indicated by parking signs."

13. In Part C of Schedule 2 -

(a) the entry relating to approved parking place No. AC6 is deleted.


(b) immediately after the entry relating to approved parking place No. AC6a there is inserted the following additional entry:

No	Situation	Approved Parking Place
"AC6b	Courtil St Jaques Estate	The portion of the south side of the one-way loop road immediately to the east of the junction with the main estate road indicated by signs as being reserved for persons in possession of a disabled person's badge."

14. This Order may be cited as The Parking Places (Amendment) Order, 1994

15. This Order shall come into force on the 1st day of August, 1994
