The Parking Places (Amendment) Order, 2002Made 24th May, 2002Coming into operation on 27th May, 2002

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1991, as amended(b) is further amended in accordance with Articles 2 to 5 inclusive of this Order.
2. In Part B of Schedule 2, immediately following the entry relating to Approved Parking Place No. AB24, the following entry is inserted-

“AB25	South Esplanade, St Peter Port	The portion of road immediately to the west of the Bus terminus to the south of Disc Parking Place DB2.”

3. In Part C of Schedule 2, for the entry relating to Approved Parking Place AC6b, substitute the following entry -.

“AC6b	Victoria Avenue, St Sampsons	The portion of the north side of the road as near as may be to "Seefield", within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.”

4. In Part C of Schedule 2, for the entry relating to Approved Parking Place AC12, substitute the following entry -.

“AC12	Les Genats Estate, Castel	The portion of road as near as may be to No. 61, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.”

5. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC15 the following entries are inserted-

"AC16	St Julian's Avenue	The portion of road to the west of the un/loading bay near the junction of Les Vauxlaurens, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."
"AC17	Route Isabelle	The portion of road as near as may be to No. 3, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

6. This Order may be cited as the Parking Places (Amendment) Order, 2002.
7. This Order shall come into force on the twenty-seventh day of May, 2002.
