THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by the Health Service (Pharmaceutical)(Guernsey) Law, 1972, as modified by the Health Service (Pharmaceutical)(Prescribed Appliances)(Guernsey) Ordinance, 1977, and of all other powers enabling it in that behalf, hereby orders:-

Amendment of regulation eight of the principal regulations

1. Paragraph (2) of regulation eight of the Health Service (Pharmaceutical)(Prescribed Appliances)(Guernsey) Regulations, 1977 (a), as amended (b) (hereinafter referred to as "the principal regulations"), is hereby further amended as follows:-

- (a) in sub-paragraph (b) thereof, the figures and words "22.75 per centum" are hereby repealed and the words "twenty-two per centum" are hereby substituted therefor;
- (b) in sub-paragraph (c) thereof, the figures and word "26 pence" are hereby repealed and the words "twenty-three pence" are hereby substituted therefor;
- (c) in sub-paragraph (d) thereof, the figures and word "3.75 pence" are hereby repealed and the figures and word "4.5 pence" are hereby substituted therefor.

Repeal

2. The Health Service (Pharmaceutical)(Prescribed Appliances) (Amendment)(Guernsey) Regulations, 1979 (c), and the Health Service (Pharmaceutical)(Prescribed Appliances)(Amendment)(No.2)(Guernsey) Regulations, 1980 (d) are hereby repealed.

Citation, collective title and commencement

3. (1) These regulations may be cited as the Health Service (Pharmaceutical)(Prescribed Appliances)(Amendment)(Guernsey) Regulations, 1982.

(2) These regulations together with the Health Service (Pharmaceutical)(Prescribed Appliances)(Guernsey) Regulations, 1977 (e), the Health Service (Pharmaceutical)(Prescribed Appliances) (Amendment)(No.2)(Guernsey) Regulations 1979(f) and the Health Service (Pharmaceutical)(Prescribed Appliances)(Amendment)(Guernsey) Regulations, 1980 (g) may be cited together as the Health Service (Pharmaceutical) (Prescribed Appliances)(Guernsey) Regulations, 1977 to 1982.

(3) These regulations shall be deemed to have come into operation on the first day of January, nineteen hundred and eighty-two.
