**The Waste Disposal Charges  
Regulations (No. 2), 2007**

**THE PUBLIC SERVICES DEPARTMENT**, in its capacity as Waste Disposal Authority<sup>a</sup> under, and in exercise of the powers conferred on it by section 32(2)(c) of, the Environmental Pollution (Guernsey) Law, 2004<sup>b</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Waste Disposal Charges.**

1. The charges set out in the schedule to these Regulations are prescribed for the purposes of section 32(2)(c) of the Environmental Pollution (Guernsey) Law, 2004 in respect of the disposal of waste of the types, and at the sites, referred to therein.

**Repeal.**

2. The Waste Disposal Charges Regulations, 2007 are hereby repealed.

**Interpretation.**

3. (1) The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of these Regulations as it applies to the interpretation of an enactment.

(2) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

**Citation and commencement.**

4. These Regulations may be cited as the Waste Disposal Charges Regulations (No. 2), 2007 and shall be deemed to have come into force on the 1<sup>st</sup> May, 2007.

SCHEDULE  
WASTE DISPOSAL CHARGES

The following charges, or rates of charge, apply in relation to the disposal of the types of waste at the sites indicated, subject to a minimum charge of £10 for each weighed load, provided that for the period 1 May to 30 June 2007, the charges, or rates of charge, indicated in brackets will apply in relation to the disposal of waste by, or on behalf of, any of the Parishes of Guernsey or the States of Alderney -

- (a) *Disposal at Mont Cuet -*
  - (i) standard waste including green waste (7½ inch)- £115 (£90) per tonne,
  - (ii) waste subject to major contamination - £172.50 (£135) per tonne,
  - (iii) inert waste - £230 per tonne,
  - (iv) notifiable special waste - £230 per tonne,  
non-notifiable pre-sorted special waste - £115 per tonne,
  - (v) commercial green waste (½ inch)- £15 per tonne,
  - (vi) private household waste - £1 per bag.
  
- (b) *Disposal at Waste Segregation Facility -*
  - (i) standard waste - £115 per tonne,
  - (ii) reload charge - £50,
  
- (c) *Disposal at Longue Hougue -*
  - (i) standard waste - £10 per tonne,
  - (ii) reload charge - £15,
  - (iii) black bag waste - £1 per bag.

## EXPLANATORY NOTE

These Regulations, made by the Public Services Department in its capacity as Waste Disposal Authority under the Environmental Pollution (Guernsey) Law, 2004, prescribe the charges payable in order to dispose of waste at the Authority's waste disposal sites as from the 1<sup>st</sup> of May 2007.
