THE GUERNSEY SOCIAL SECURITY AUTHORITY, in exercise of the powers conferred upon it by Part IIIA and section 35 of the Health Service (Benefit) (Guernsey) Law, 1990, as amended (a), and as modified by the Health Service (Physiotherapy Benefit) Ordinance, 1995(b), and of all other powers enabling it in that behalf, hereby orders:-

**Amendments**

1. For the Second Schedule to the Health Service (Physiotherapy Benefit) Regulations, 1995 (c) substitute the Schedule set out in the Schedule to these regulations.

**Extent**

2. These regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

**Citation**

3. These regulations may be cited as the Health Service (Physiotherapy Benefit) (Amendment) Regulations, 1997.

Treatment in Hospital : 30 minutes	£16.97
Enhanced rate	£25.46
Treatment in Hospital : 20 minutes	£11.71
Enhanced rate	£17.57
Treatment in Hospital : 10 minutes	£ 5.94
Enhanced rate	£ 8.91

The enhanced rate is payable for special call outs between 8.00 pm and 8.00 am Monday to Friday and for Saturdays, Sundays and Public Holidays."

## **EXPLANATORY NOTE**

(This note is not part of the Regulations but is intended to indicate their general purport).

These Regulations amend the Health Service (Physiotherapy Benefit) Regulations, 1995, by increasing the scale of fees payable to authorised suppliers of physiotherapy benefit.
