The Driving Licences (Increase of Fees) Regulations, 2007Made----- 24th April, 2007

Laid before the States on -----

Coming into operation on----- 1st June, 2007

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred upon it by sections 2A(b) and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987, as amended ^a, hereby orders:-

Amendments to 1995 Ordinance

1. The Driving Licences (Guernsey) Ordinance, 1995, as amended ^b, is amended as follows.
2. For section 7 of the Ordinance, substitute the following:-

“... 7. (1) There shall be different fees payable for the plastic licences (“old style licences”) and polycarbonate UV dull licences (“new style licences”).

(2) The Committee shall determine the date from which new style licences are to be issued, and no old style licences shall be issued on or after that date.

(3) Subject to subsection (4), the fees payable for licences issued under this Ordinance shall be:

- (a) in the case of an old style licence of a description specified in the first column of the Table set out in Schedule 3 to this Ordinance, the fee specified in the second column of that Table; or

(b) in the case of a new style licence of a description specified in the first column of the Table set out in Schedule 3 to this Ordinance, the fee specified in the third column of that Table; and

(4) Where, in the case of licences included within paragraphs (1) to (3) or in paragraph (5) of the said Schedule, a licence is granted, pursuant to the provisions of section 8, for a period which is less than ten years, the fee payable in respect of the issue of such licence shall be such reduced sum as the Committee shall determine.”

3. For Schedule 3 of the Ordinance substitute the following Schedule –

and the Committee is required to grant a new licence free of charge		
(5) A licence issued in exchange for a licence issued by the competent authority in a country outside the Island	£26.50	£40.00
(6) The first licence granted to a person after the expiration of a period of disqualification imposed upon him by an order of the court where -		
(a) the licence will remain in force for less than six years	£15.90	£20.00
(b) the licence will remain in force for more than six years, for each year or part thereof until its expiration	£2.65	£4.00
(7) A licence granted pursuant to section 11(2) of the principal Law	£7.95	£10.00
(8) A duplicate licence	£7.95	£20.00"

The Driving Licences (Increase of Fees) Regulations, 2007

Explanatory Note

These regulations set a new scale of fees that are chargeable for the new style driving licences with effect from 1st June 2007. The increased fees will only apply to the new style licences that will only be issued after a date determined by the Committee, and which will replace the old style licences.
