**THE GUERNSEY SOCIAL SECURITY AUTHORITY**, in exercise of the powers conferred upon it by sections 14 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990(a), and of all other powers enabling it in that behalf, hereby orders:-

**Amendments**

1. (a) For the Second Schedule to The Health Service (Payment of Authorised Suppliers) Regulations, 1990(b), substitute the provisions set out in the First Schedule to these Regulations.

(b) For the Third Schedule to the Health Service (Payment of Authorised Suppliers) Regulations, 1990(b), substitute the provisions set out in the Second Schedule to these Regulations.

**Citation**

2. These Regulations may be cited as the Health Service (Payment of Authorised Suppliers)(Amendment) (No. 4) Regulations, 1995.

**Commencement**

3. These Regulations shall come into force on the 1st day of January 1996.
