**THE SOCIAL SECURITY DEPARTMENT**, in exercise of the powers conferred upon it by sections 39 and 116 of the Social Insurance (Guernsey) Law, 1978, as amended<sup>a</sup>, and of all other powers enabling it in that behalf, hereby orders:-

### **Amendment**

1. The five Schedules to the Social Insurance (Benefits) Regulations, 2003<sup>b</sup> are revoked and replaced by the five Schedules to these Regulations.

### **Citation**

2. These Regulations may be cited as the Social Insurance (Benefits) (Amendment) Regulations, 2005.

### **Commencement**

3. These Regulations shall come into force on 2nd January, 2006
