**The Aircraft Charges (Amendment)
(Guernsey) Ordinance, 1965**

THE STATES, in pursuance of their Resolution of the twenty-fourth day of November, nineteen hundred and sixty-five, and in exercise of the powers now vested in them under paragraph (3) of Article seven of the Air Navigation (Guernsey) Order, 1926 (*a*), and of all other powers thereunto them enabling, hereby order:—

1. The Aircraft Charges (Guernsey) Ordinance, 1956, as amended (*b*), is hereby further amended as follows, that is to say:—

(*a*) in paragraph (*a*) of subsection (1) of section two thereof, the words “five shillings and eleven pence” are hereby repealed and the

words "six shillings and four pence" are hereby substituted therefor;

- (b) in paragraph (b) of subsection (1) of section two thereof, the words "five shillings and eleven pence" are hereby repealed and the words "six shillings and four pence" are hereby substituted therefor;
- (c) in paragraph (a) of subsection (2) of section two thereof, the words "three shillings and six pence" are hereby repealed and the words "three shillings and nine pence" are hereby substituted therefor;
- (d) in paragraph (b) of subsection (2) of section two thereof, the words "two shillings and one penny" are hereby repealed and the words "two shillings and three pence" are hereby substituted therefor;
- (e) section three thereof is hereby repealed and the following section is hereby substituted therefor—

3. Notwithstanding the provisions of subsection (1) of the last preceding section, during the months of January, February, March, November and December the fees payable in any year under the provisions of that subsection shall be reduced by fifteen per centum.";

- (f) in subsection (2) of section five thereof, the words "two shillings and four pence" are hereby repealed and the words "two shillings and six pence" are hereby substituted therefor.

2. Subsection (1) of section one of the Aircraft Charges (Amendment) Ordinance, 1959 (c), is hereby repealed and the following subsection is hereby substituted therefor—

“(1) Notwithstanding the provisions of the Aircraft Charges (Guernsey) Ordinance, 1956, as amended (hereinafter referred to as “the principal Ordinance”) instead of the fees payable by the Operator in pursuance of the principal Ordinance, as respects the Alderney Airport, there shall be paid by the Operator, as respects the year nineteen hundred and sixty-six and each year thereafter, the sum of five thousand five hundred and twenty-four pounds.”.

3. Subsection (1) of section two of the Aircraft Charges (Amendment) (Guernsey) Ordinance, 1963 (d), is hereby repealed and the following subsection is hereby substituted therefor—

“(1) Notwithstanding the provisions of the principal Ordinance, instead of the fees payable by the Operator in pursuance of those provisions in respect of each departure of any aircraft from the Guernsey Airport to the Alderney Airport and in respect of each arrival of any aircraft at the Guernsey Airport from the Alderney Airport, there shall be paid by the Operator, as respects the year nineteen hundred and sixty-six and each year thereafter the sum of two thousand four hundred and sixty pounds.”.

4. The Ordinances set out in the left hand column of the Schedule to this Ordinance are hereby

5. (1) This Ordinance may be cited as the Aircraft Charges (Amendment) (Guernsey) Ordinance, 1965.

(2) This Ordinance, the Aircraft Charges (Amendment) (Guernsey) Ordinance, 1963, the Aircraft Charges (Amendment) Ordinance, 1959, and the principal Ordinance may be cited together as the Aircraft Charges (Guernsey) Ordinances, 1956 to 1965.

6. This Ordinance shall come into force on the first day of January, nineteen hundred and sixty-six.
