The Airport Fees (Amendment) Ordinance, 1977

THE STATES, in pursuance of their Resolution of the thirtieth day of March, nineteen hundred and seventy-seven, and in exercise of the powers conferred upon them by section one of the Alderney (Application of Legislation) Law, 1948(a), and of all other powers enabling them in that behalf, hereby order:—

1. The Airport Fees Ordinance, 1975, as amended(b), is hereby further amended as follows:—

(a) in subsection (2) of section one thereof—

(i) in paragraph (a) the word “sixty” is repealed and the words “seventy-five” are substituted therefor;

(ii) in paragraph (b) the words “one pound and fifty” are repealed and the words “one pound and eighty-five” are substituted therefor;

- (b) in subsection (2) of section two thereof the words "fifty-five" are repealed and the words "seventy-five" are substituted therefor;
- (c) in subsection (3) of section four thereof—
 - (i) in paragraph (a) the word "fifty" is repealed and the words "seventy-five" are substituted therefor;
 - (ii) in paragraph (b) immediately after the words "one pound" there are inserted the words "and eighty-five new pence";
- (d) in subsection (4) of section four thereof the words "fifty-five" are repealed and the words "seventy-five" are substituted therefor;
- (e) the First Schedule thereto is repealed and the Schedule set out in the First Schedule to this Ordinance is substituted therefor;
- (f) the Second Schedule thereto is repealed and the Schedule set out in the Second Schedule to this Ordinance is substituted therefor;
- (g) the Third Schedule thereto is repealed and the Schedule set out in the Third Schedule to this Ordinance is substituted therefor.

Repeals.

2. The Ordinances set out in the left hand column of the Fourth Schedule to this Ordinance are hereby repealed to the extent set out in the right hand column of that Schedule.

Extent.

3. This Ordinance shall have effect in the Islands of Guernsey and Alderney.

4. This Ordinance may be cited as the Airport Citation. Fees (Amendment) Ordinance, 1977.

5. This Ordinance shall come into force on the first day of April, nineteen hundred and seventy-seven. Commencement.

Aircraft not exceeding three metric tons maximum permissible weight	88p per five hundred kilograms or part thereof
Aircraft exceeding three metric tons maximum permissible weight	£1.75 per metric ton or part thereof

PART II

Navigational services fees

Classes of aircraft	Rates of navigational services fee
Aircraft not exceeding three metric tons maximum permissible weight	87p per five hundred kilograms or part thereof
Aircraft exceeding three metric tons maximum permissible weight	£1.75 per metric ton or part thereof

PART III

Private aircraft fees

Classes of private aircraft	Amount of fee
Aircraft not exceeding one metric ton maximum permissible weight	£1.75
Aircraft exceeding one metric ton but not exceeding one and one half metric tons maximum permissible weight	£2.65
Aircraft exceeding one and one half metric tons but not exceeding two metric tons maximum permissible weight	£3.50
Aircraft exceeding two metric tons but not exceeding two and one half metric tons maximum permissible weight	£4.35
Aircraft exceeding two and one half metric tons but not exceeding three metric tons maximum permissible weight	£5.25

Classes of aircraft	For each period of twenty-four consecutive hours or part thereof
Aircraft not exceeding three and one half metric tons maximum permissible weight	45p for each five hundred kilograms or part thereof
Aircraft exceeding three and one half metric tons but not exceeding ten metric tons maximum permissible weight	£3.60
Aircraft exceeding ten metric tons but not exceeding twenty metric tons maximum permissible weight	£7.05
Aircraft exceeding twenty metric tons but not exceeding thirty metric tons maximum permissible weight	£10.55
Aircraft exceeding thirty metric tons but not exceeding one hundred metric tons maximum permissible weight	£10.55 plus £2.25 for each ten metric tons or part thereof in excess of thirty metric tons maximum permissible weight
Aircraft exceeding one hundred metric tons maximum permissible weight	£26.30 plus £1.80 for each ten metric tons or part thereof in excess of one hundred metric tons maximum permissible weight.
